**ORDINANCE NO. 21-22**

**AN ORDINANCE FOR ADDITIONAL APPROPRIATIONS (STREET  
DEPARTMENT/PUBLIC WORKS)**

**WHEREAS**, the City of Muncie Street Department/Public Works requires the establishment of a construction inspector to replace the Supervisor I position currently listed in the Salary Ordinance; and

**WHEREAS**, the new position has a salary larger than the amount previously appropriated for the Supervisor I position; and

**WHEREAS**, it has been determined that it is necessary to make certain amendments within the Street Department budget to reflect these changes;

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:**

**Section 1.** The following additional sums of money are hereby appropriated for the purposes specified, subject to the laws governing the same. Fund 35 is titled "Street Department."
