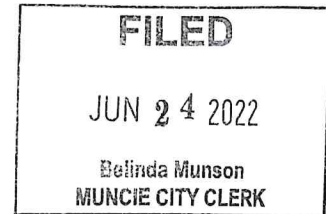

**A RESOLUTION FOR TRANSFER OF APPROPRIATIONS (ANIMAL SHELTER)**




