


ORDINANCE 34-22



AN ORDINANCE AMENDING CHAPTER 12 OF THE CITY OF MUNCIE CODE OF ORDINANCES (REDISTRICTING)

WHEREAS, Indiana law requires the Common Council to consider redistricting the City Council districts every ten years following the Federal Census;

WHEREAS, Indiana Code § 36-4-6-3 requires second class cities to divide the city into six (6) districts that: (1) are composed of contiguous territory, except for territory that is not contiguous to any other part of the city; (2) are reasonably compact; (3) do not cross precinct boundary lines; and (4) contain, as nearly as is possible, equal population; and

WHEREAS, the Redistricting Committee of the Common Council reviewed the population for each district from the Federal Census and a map of the current districts to determine whether the districts should be redrawn; and

WHEREAS, the Redistricting Committee has recommended to the Common Council that the current districts should remain the same;

NOW THEREFORE BE IT ORDAINED, by the Common Council of the City of Muncie, Indiana, as follows:

Section 1: The following Sections of Chapter 12 of the City of Muncie Code of Ordinances shall be amended to read as follows:

Sec. 12.03 Councilmanic District No. 1

Councilmanic District No. 1 shall consist of the following precincts: 9, 13, 22, 28 and 29.

Sec. 12.04 Councilmanic District No. 2.

Councilmanic District No. 2 shall consist of the following precincts: 6, 8, 10, 26, 34, 36, and 38.

Sec. 12.05 Councilmanic District No. 3.

Councilmanic district No. 3 shall consist of the following precincts: 1, 14, 15, 23, 25, 33, and 81.

Sec. 12.06 Councilmanic District No. 4.

Councilmanic district No. 4 shall consist of the following precincts: 2, 3, 4, 40, 42, 45, 47, 50, 58, and 74.

Sec. 12.07 Councilmanic District No. 5.

Councilmanic District No. 5 shall consist of the following precincts: 7, 27, 35, 39 and 92.

Sec. 12.08 Councilmanic District No. 6.

Councilmanic District No. 6 shall consist of the following precincts: 11, 12, 18, 19, 20, 46 and 48.


Section 2. This Ordinance shall take effect upon approval by the Mayor of the City of Muncie and any publication required by Indiana law.

Adopted by the Common Council of the City of Muncie this 7th day of November, 2022.


