Craig Wright explained that we have an ordinance filed for the next city council meeting for additional appropriations. Another question she had was for supplies for the concession stand at Tuhey Park, I do not have a quall with them and I am sure they are legitimate charges and do not ever have anything that shows the income from them for concessions at Tuhey. Craig indicated that looks at the invoices coming across his desk for Chips, Hot Dogs, hot dog buns, nacho cheese etc. We have no way of knowing that it balances out or breaks even.



Approval given by Deputy Police Chief, Chris Deegan and Muncie Fire Chief, Robert Mead. **Noise Exemption:** 5:00 p.m. to 9:00 p.m. with a DJ playing music from parking lot we anticipate 200 people attending the block party. This is an alcohol free event. President Gregory entertained a motion. Lola Mauer moved to approve street closure and noise exemption as presented. Ted Baker provided the second. Motion passed by voice vote.
8. **Street Closing Application from "Old Washington Street Festival":** Kim Miller, Chairman of the Old Washington Street Festival came forward to get approval to close E. Washington Street between Madison & Beacon at 3:00 p.m. Friday, September 16, 2022 until 8:00 p.m. Sunday, September 18, 2022 for the festival. Also closed will be the cross streets for Monroe, Vine, Pershing, Hackley, Ebright and Beacon between Main St. & Gilbert St. This is our 48th festival. Approval given by Nathan Sloan, Muncie Chief of Police and Muncie Fire Chief Robert Mead. President Gregory entertained a motion. Lola Mauer moved to approve street closures for the 48th Annual Old Washington Street Festival" as presented. Ted Baker provided the second. Motion passed by voice vote.
