They come before us and it just seems like we go through them very quickly but he vets every single one of them making sure our community is safe and I appreciate that. Thank you Chief Sloan.

18. Muncie Police Chief, Nathan Sloan FYI License Plate Reader contract coming soon to the Board of Works: Chief Sloan came forward to explain Flock safety is License Plate reader technology that the Muncie Police Department would like to bring into town because we having all kinds of problems with drive by shootings and random crime and things like that. This is not just a Muncie problem it is an everywhere problem right now. We are trying to bring this technology into Muncie so we can start solving these crimes more efficiently and have this system as a force multiplier. After speaking to one of detectives, he said he was doing seven times the work of any other detective of that department, not just, because he is a good detective but because of this system. The Flock Company gave us access over this last weekend when we had a homicide. This will be in effect soon as two weeks, and once that is done assuming that we like it and we are getting the results we wanted. We will have an invoice to come to you at The initial year including all the installation and everything will be about that time. \$63,000 we will also have access to other communities that have the flock system, which is a big deal for us. At points of ingress or egress within the city or congested areas where you expect a lot of traffic, the idea is to gain as much intelligence as you can, as far as who is here. The cameras only care about the license plate and the car and it takes a picture, then you can go back and search through that based on the specific make or color of the car, features of the car of what you are looking for and narrow down the search very quickly. If you are looking at wide geographic area let's say from here to Indianapolis you are going to pull a lot of cars and you will have to search through those for instance which ones have a spoiler, cracked front or rear windshield, which ones have tinted windows for the car you are hopefully looking for in a timely manner. This a hard delete at 30 days and we won't have years of information stored or anything like that for instance if we have a homicide and we need to keep that information we can save it and download it on a hard drive but the rest of the information will be deleted.
