- 9. Stephanie Hutchinson, Community Development CDBD Public Service Contract: Stephanie came before the board requesting the transfer of Funds from HUD, which would be no cost to the city. The first of which being, Christian Ministries of Delaware County for \$25,000.00 these funds will go towards staff pay for the Men's emergency shelter from June 1st 2022 to May 31st 2023. Muncie Mission for \$40,000.00 for going toward staff pay from June 1st 2022 to May 31st 2023 to administer services to HUB for homeless services. A Better Way Service \$38,000.00 and the funds will cover pay for caseworkers from June 1, 2022 to May 31 2023. Lastly, Home Savers of Delaware County for \$14,000.00 the funding will be used toward the Activity Administrator Salary. The activity administrator duties include a variety of administrative functions including maintaining records for grants, answering phones and other necessary duties to ensure smooth operation. President Gregory entertained a motion to approve. Lola Mauer moved to approve Contracts as printed. Ted Baker provided the second. Motion passed by voice vote.
- 10. Chris Deegan, Deputy Police Chief regarding the Noise Exemption process/application: Chris came before the board due to the high number of callins they experienced this past weekend especially in Ball State. He is requesting the cut off time be Midnight and possibly have a Police Department and Fire Department approval section before them being approved by the Board of Works members. He also brought along Sargent Dan Vogal who is one of the midnight shift supervisors whom is dealing these complaints in person. He said that there are always issues when alcohol is in involved especially after midnight. He said they had robberies, shootings, fights as well as thefts. President Gregory said that this would be a good idea to change on the permits to stopping the exemption at midnight. She also mentioned that before these go to the Board of Works meeting that police and/or fire would be able to give any details on prior complaints before it being approved. She then asked that we go over the paperwork and put this on the agenda for next week on how to properly deal with these so we do not cause any issues. She also mentioned the decibel level being only 90, to which Chris stated that that is not very loud at all. President Gregory also mentioned fines that can be charged. President Gregory said that we will just prepare for this to come before the board next week after being sent the request form as well as the ordinance.
- 11. Noise Exemption Authorization from Rockie Jernigan for 410 E. Willard: Rockie came forward with his request for a noise exemption for September 24<sup>th</sup> & October 1st, 2022 from 4:00 PM and to not go past 12:00 AM for Community Gathering. Rockie also stated that the police department stopped by his event due to the noise from the music, but it was only called in on after midnight. President Gregory stated a good way to tell how loud something is by walking a block away from the party area and seeing how loud it would be for the neighbors. President Gregory entertained a motion. Lola Mauer moved to approve noise exemption as presented. Ted Baker provided the second. Motion passed by voice vote.
