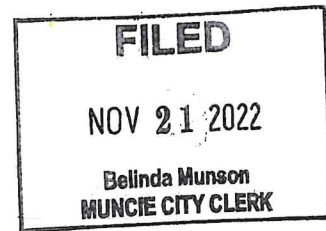

**A RESOLUTION FOR TRANSFER OF APPROPRIATIONS (Police Department)**


