3. **Roll Call Members Present:** Linda Gregory – Ted Baker - (Absent-Lola Mauer)
4. **Approval of the Minutes for the November 23, 2022:** President Gregory entertained a motion to approve. Ted Baker moved to approve minutes from the November 23, 2022 meeting as printed. Linda Gregory provided the second. Motion passed by voice vote.
5. **Register of Claims:** Craig Wright, City Controller, presented this week claims


