She informs some addresses were removed from the list. There was also the addition of two properties later added that had bids sent out.* Questions called. Lola Mauer made a motion to accept the bids as presented. President Baker provided the second. Motion passed by voice vote.

- 7. Contract for Historic Rehabilitation at 719 W. Charles St.: Gretchen Cheeseman, Community Development Director, explains this is a contract between Community Development and Old West End Neighborhood Economic Redevelopment Corporation who is a neighborhood reinvestment corporation acting as a recipient to replace the roof on a building they own at 719 W. Charles St. They are preparing to enter a contact with Hochadel Roofing for the work and have an architect that is reviewing and preparing specifications for the building and supervising the work (such as signing off on pay applications). The cost of the roof replacement is \$116,800 but it is a big building. Also included in the contract is rebuilding a bay on the west side. It is more than roofing as they will be replacing all the decking, taking the chimney down to below the roof and putting in all new gutters. It is a big project and is located in a historic district so has to be done according to special standards that not every other roof has to follow within the federal Community Development Dept. money. She requests approval of this contract to the sub recipient, Old West End Neighborhood Economic Redevelopment Corporation. Lola Mauer made a motion to accept the contract. President Baker provided a second. Questions called. Motion passed by voice vote.
- 8. Bid opening Riverview Park Design: David Heilman, FlatLand Resources, explains they did the Riverview Park redesign design work and put together the documents for this. One bid was received. Lola Mauer reads Pridemark Construction Inc. bided the amount of \$307,510. Matter taken under advisement.
- 9. IAFF Local #1348 presenting Street Collections for 2023: Jason Chafin, Union President for Muncie Firefighters Local #1348, explains every year they come before the Board of Public Works to inform of the street collections they do. They have six dates chosen for this year and will be out from 4:00 PM to 6:00 PM on June 16th (3 turn), June 30th (1 turn), July 14th (2 turn), August 4th (3 turn), August 25th (1 turn), and September 15th (2 turn). Each shift does it twice. The collection intersection locations will remain the same; Jackson and Madison St, Memorial and Hackley, 8th St. and Batavia, 18th St. and Macedonia, Tillotson and Bethel Ave., and Walnut and Centennial. President Baker inquires what the funds collected will be used for. Mr. Chafin states they divide the funds up four ways, 30% goes to Toys-for-Tots, 30% goes to the Delaware County Special Olympics, 30% goes to the Muscular Dystrophy Association and 10% comes back to their Local #1348 charities that allows them to do little league sponsorships and things like that. Lola Mauer made the motion to approve the proposal. President Baker provided the second. Questions called. Motion passed by voice vote.
