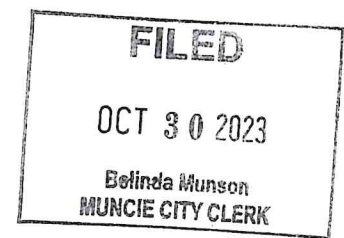


ORDINANCE NO. 23 -23



AN ORDINANCE FIXING THE SALARIES FOR ALL ELECTED OFFICIALS OF THE CITY OF MUNCIE, INDIANA, FOR THE YEAR 2024

WHEREAS, It is provided by Indiana Code 36-4-7-2 that the City Legislative Body shall, by ordinance, fix the compensation of all elected officials, and

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA, THAT:

SECTION 1. Pursuant to Indiana Code 36-4-7-25, the following salaries, payable from the General Fund, are hereby fixed for the Mayor, City Judge, City Clerk and Common Council of the City of Muncie, Indiana, for the year 2024.

All salaries set under this ordinance will be effective on January 1, 2024. The first payday will be January 13, 2023 and will be computed using 2024 pay rates.

City Judge	\$5,766.92	Bi-Weekly
President of the Muncie Common Council	\$567.86	Bi-Weekly
Members of the Muncie Common Council	\$548.25	Bi-Weekly
City Clerk	\$2,158.47	Bi-Weekly


SECTION 2. This ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor of the City of Muncie, Indiana, and such publications as are required by law.
