- 1. Board of Public Works and safety, City of Muncie, State of Indiana, met in City Hall Auditorium, at 9:00 A.M.
- 2. Pledge of Allegiance
- 3. Roll Call Members Present: Ted Baker Lola Mauer Linda Gregory
- 4. Approval of the Minutes for July 24, 2024: President Ted Baker entertained a motion to approve. Lola Mauer moved to approve minutes from the July 24, 2024 meeting as printed. Linda Gregory provided a second. Questions called. Motion passed by voice vote.
- 5. Register of Claims: Craig Wright, City Controller, wished to bring attention to a few claims:

Linda Gregory moved to approve register of claims of 361 Records for a total amount of \$530,127.64 as presented. Lola Mauer provided a second. Questions called. Motion passed by voice vote.

- Professional Services Contract Approval City Hall Vending: Adam Leach, City Engineer, on behalf of the Mayor's office attests to this being a 4-year contract with FSSA which a company contracted with the state. They help people with disabilities, primarily blindness, and the contract is for keeping stock in the vending machines placed in City Hall. It is a follow-on of the state contract and that is about all he knows about it. Linda Gregory moved to approve the Professional Services Contract with FSSA. Lola Mauer provided the second. Questions called. Motion passed by voice vote.
- Office of Community Development Contract Approval for partially HOME funded new construction of a single-family home to be sold to a low to moderate income homebuyer: President Ted Baker voiced tabling this until Community Development provides further information. No formal action is taken and item is Tabled.

8. Street Closure Application – Muncie OUTreach LGBTQ+ Center (August 31): Jeri Knowlton-Simard, Interim Executive Director of Muncie OUTreach, described a Muncie Pride Festival planned for August 31 on Canan Commons. Last year about 2,500 people attended and they are looking to close the same streets which were S. Walnut from Charles to the roundabout/or Seymour as well as S. Mulberry from Charles to the roundabout/or Seymour.

President Baker has one concern about the closure being from 8:00 AM to 9:00 PM and that's is people coming in from the south on Walnut Street having no way to get around downtown if Mulberry is closed. This is going to be a big detour so how will traffic be directed? Ms. Knowlton-Simard informed they plan to put signs up alerting the closure ahead of time but if needed they can put up signs letting people know where to go. The Board discussed that the reroute would take people to Liberty St and anyone coming in from out of town won't have a clue what to do or where to reroute.

Linda Gregory made the comment that perhaps 13 hours is too long to have Mulberry closed. Ms. Knowlton-Simard explained the reason they close it for so long is because they don't want people to park where they plan to have vendors. They are open to having the road closed for less time as they probably won't start setting up until Noon. President Baker relays if their concern is vending then he would rather they put up barriers/cones to block the vendors for safety. This is done at this particular location a lot for other events so maybe they can just rather say no parking. Ms. Knowlton-Simard claimed it would be a safety issue because many people attend this event, both vendors and attendees, and if the street isn't closed then they wouldn't adequality be able to visit all vendor locations safely. Gregory suggested keeping one (eastern) lane of traffic available to head north. President Baker assured the problem with that is they would need barriers all the way through that stretch to keep the other lane closed. Gregory believes that being better than having the road closed for 13 hours. Ms. Knowlton-Simard, not trying to be argumentative, questions the concern now when in the past there was no issue with the same streets being closed. President Baker claimed he was just reviewing the application and thought about people coming in from the south side of Muncie; if it were him, he wouldn't know what to do. It is just an all-day road closure on a Saturday that might be an inconvenience for other people and the Board just wanted to balance that with safety.

Laura Janney explained last year they were able to direct people down a road to Liberty; being unable to remember the name of the road but recalled its location right by the hotel between where The Star Press building used to be. President Baker was under the impression that would be the circumstance again but was just thinking of out-oftowners and other downtown vendors or businesses. Lola Mauer questioned if Mulberry is usually shut down for the other Thursday events held at Canan Commons. It isn't believed so. According to Janney, they plan to have 130 vendors and 6 food trucks which is going to take up that entire space. Lola Mauer stated approval from the Muncie Police Chief and Fire Chief have been obtained. Lind/Gregory does not have a problem as long as they obtain adequate signage to direct people where to go. President Baker suggested getting with the Street Department but Adam Leach relayed that typically most people have to get a private vendor to provide any detour signs. He was only bringing up his concerns in reading the application and is okay with it since it has been approved by the Police and Fire Chief. The BOW only request is to close the street for the minimal amount of time possible, only when they will really need the closure. It will be very much appreciated. Questions called. Linda Gregory moved to approve the street closure and parade permit. Lola Mauer provided the second. Motion passed by voice vote.

9. Street Closure Applications(s) – Ball State University Police Department, 2024 Home Football Games (September 7, October 5, October 26, November 5, and November 23): Chief Deputy David Bell, Ball State University Police Department, is here to request the street closures of Tillotson between McGalliard and Bethel on September 7, October 5, October 26, November 5, and November 23. These are all the same streets that have been closed in years prior. Indiana State Police will be at McGalliard and Tillotson and Muncie Police will be at Bethel and Tillotson. The closure is 3 hours pregame and opened once the game starts. They close it again at the end of the 4th quarter and open it as soon as traffic is done. They also leave it open for emergency vehicles and people are let people through at the traffic light if in route to the hospital or in the case of an emergency. They are very accommodating and staff the intersections the entire time. Lola Mauer moved to approve the street closure applications for the 2024 Ball State home football games. Linda Greogry provided the second. Motion passed by voice vote.
