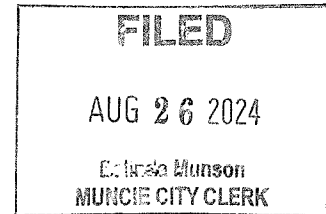

WHEREAS, it has been determined that it is now necessary to add appropriations for Muncie Police Department related expenses.


