ORDINANCE NO. 34 -24

AN ORDINANCE FIXING THE SALARIES FOR ALL ELECTED OFFICIALS OF THE CITY OF MUNCIE, INDIANA, FOR THE YEAR 2025

WHEREAS, It is provided by Indiana Code 36-4-7-2 that the City Legislative Body shall, by ordinance, fix the compensation of all elected officials, and

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA, THAT:

SECTION 1. Pursuant to Indiana Code 36-4-7-25, the following salaries, payable from the General Fund, are hereby fixed for the Mayor, City Judge, City Clerk and Common Council of the City of Muncie, Indiana, for the year 2025.

All salaries set under this ordinance will be effective on January 1, 2025. The first payday will be January 10, 2025 and will be computed using 2025 pay rates.
