**AN ORDINANCE AMENDING CHAPTER 52 OF THE MUNCIE CITY ORDINANCES
ENTITLED WASTE AND LITTER; CARE OF PREMISES**

WHEREAS, it has been determined that it is necessary to update the traffic code within the Muncie City Ordinances; and

WHEREAS, the City of Muncie desires to update said sections of the code to correlate with updated versions of Indiana State Code and ordinances passed under the Muncie Common Council;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:

Section 1. Section 52.20 has been superseded by Section 98.02. Therefore, Section 52.20 is repealed in its entirety.

Section 2. Section 52.21 has been superseded by Section 98.05. Therefore, Section 52.21 is repealed in its entirety.

Section 3. Section 52.22 has been superseded by Section 152.06. Therefore, Section 55.22 is repealed in its entirety.

Section 4. Section 52.45 is amended to read as follows

Sec. 52.45 – Enforcement Procedure.

- (A) Procedure for enforcement of the civil penalties contained herein shall be governed by IC 34-28-5-0.2 through IC 34-28-5-17, as it applies to the city, as from time to time amended.
- (B) In addition to any other penalty provided for herein, the city may take such civil action as provided by law, including, but not limited to, injunctive relief, abatement of a nuisance, or imposition of a lien for expenses.

Section 5. This Ordinance shall be in full force and effect upon its passage by the Common Council, its approval by the Mayor of the City of Muncie and its publication in accordance with the law.
