
MUNCIE CITY COUNCIL ORDINANCE NO. 525



AN ORDINANCE AMENDING CHAPTER 77 (PARKING REGULATIONS) OF THE MUNCIE CODE OF ORDINANCES (PAYMENT LOCATION AND DISTRIBUTION)

WHEREAS, it has been determined that it is necessary to update Chapter 77 – Parking Regulations within the Muncie City Ordinances; and

WHEREAS, the City of Muncie desires to update said chapter of the code to address issues related to payment distribution

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:

Section 1. That Chapter 77, Section 77.99(C) – Parking Regulations is amended to read as follows

Sec. 77.99(C) Payment Location and Distribution

- (C) Payment Location and Distribution
 - (1) Payment(s) of fines, fees and/or penalties shall be made at the Office of the City Clerk and any additional location(s) designated by the Parking Enforcement Manager and the Ordinance Violations Bureau.
 - (2) Payment(s) of fines associated with this Chapter shall be deposited into the Parking Meter Fund, Fund 541.
 - (3) Payment(s) of administrative fees shall be deposited into the General Fund, 101-00-351011, Parking Violations City Clerk.

Section 2. This Ordinance shall be in full force and effect upon its passage by the Common Council, its approval by the Mayor of the City of Muncie and its publication in accordance with the law.
