- 1. **Board of Public Works and safety, City of Muncie, State of Indiana, met in City Hall Auditorium, at 9:00 a.m.**

- 3. **Roll Call Members Present:** Ted Baker – Lola Mauer – Linda Gregory
- 4. **Approval of the Minutes for January 15, 2025:** President Ted Baker entertained a motion to approve. Lola Mauer moved to approve minutes from the January 15, 2025 meeting as presented. Linda Gregory provided a second. Questions called. Motion passed by voice vote.
- 5. **Register of Claims:** Craig Wright, City Controller, wished to bring attention to a few claims:

Questions called. Linda Gregory had a few questions about some claims found on Page 10, Muncie Public Works, with fairly vague descriptions that Mr. Wright advised were for shipping charges. She would like to remind the people entering them to be a little more specific. Mr. Wright will follow-up on that and relayed two are for one claim so they should have been placed under one. Linda Gregory moved to approve register of claims of **181 Records** for a total amount of **\$740,838.24** as presented. Lola Mauer provided a second. Questions called. Motion passed by voice vote.
- 6. **Street Closure Application – Muncie Mission Ministries (2/15/25):** Bob Scott, Muncie Mission, explained this is the 21st annual Walk a Mile in My Shoes event scheduled for February 15. They will be walking from the Muncie Fieldhouse to the Muncie Mission (again) and are hopeful to have nice weather. The current cold weather we’re experiencing is a reminder of those in need. This is a major fundraiser for the Mission and are just seeking support for the event. Lola Mauer moved to approve the street closure. Linda Gregory provided the second. Questions called. Motion passed by voice vote.
- 7. **Noise Exemption Authorization – Ball State University Office of Student Life (4/25/25):** Anna Miller, Assistant Director of Spirit and Traditions in the Office of Student Life, Ball State University, presents a noise exemption authorization request for their Late Nite Carnival event scheduled for the end of April. This is alcohol-alternative programming that will last from 5:00 to Midnight. This is the 20th annual running of the event. There will not be fireworks this year as complaints were received about that from the student body so fireworks are something they plan to pivot from now on but the event is mainly for amusement (loud, singing students). It is very well-contained with

President Baker made note the authorization has been approved by the Police Chief. Motion passed by voice vote.

8. **Residential Handicap Parking Renewal – 801 E. Jackson:** President Baker announced this is for Nyelle Gilmore. Linda Gregory mentioned it is not required for the applicant to be present regarding handicap parking renewals. President Baker confirmed the applications is in order, approved of by the appropriate engineer and has been presented in a timely manner. Linda Gregory moved to approve the residential handicapped parking renewal. Lola Mauer provided the second. Questions called. Motion passed by voice vote.
