COMMON COUNCIL OF MUNCIE, INDIANA

A RESOLUTION APPROVING SETTLEMENT OF LITIGATION

WHEREAS, The City of Muncie is a Defendant in a civil suit in the United States District Court for the Southern District of Indiana titled Emanuel Montero v. City of Muncie.

WHEREAS, the Common Council for the City of Muncie ("Council") adopted Ordinance 31-20 which appropriated \$300,000.00 to the Legal Settlements department.

WHEREAS, the Council adopted Ordinance 44-20 which appropriated an additional \$150,000.00 to the Legal Settlements department.


WHEREAS, a settlement agreement resolving the above referenced civil suit was accepted by the Mayor of the City of Muncie which, pursuant to the insurance policy of the City of Muncie, requires the approval of the Council.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:

The Common Council of the City of Muncie, Indiana does hereby approve the settlement agreement between the City of Muncie and Emanuel Montero, and approves the payment of all funds required therein.




