MUNCIE CITY COUNCIL ORDINANCE NO. 20-25

AN ORDINANCE AMENDING CHAPTER 95 SECTION 95.09 OF THE CITY OF MUNICE CODE OF ORDINANCES ENTITLED "PARKS AND RECREATION"

WHEREAS, Chapter 95 of the City of Muncie Code of Ordinances outlines the power of the City of Muncie to establish and maintain parks.

WHEREAS, the Common Council of the City of Muncie desires to amend to add additional safety and public health measures for maintaining the city parks.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, DELAWARE COUNTY INDIANA THAT:

Section 1. Section 95.09 Intoxicating Beverages of the City of Muncie Code of Ordinances should be amended as follows:

§95.09 Intoxicating Beverages

- A. Except as provided in subsection (B) below, no person shall introduce any intoxicating beverages into any public park, either for his own use or for sale, or use, sell, or give away the same.
- B. The prohibition provided in subsection (A) shall not apply in the following public parks and as provided below:
 - (1) Within leased spaces at Prairie Creek Reservoir. The leased spaces at Prairie Creek Reservoir include the dock lease spaces and the seasonal campsite lease spaces.
 - (2) Within Cannon Commons provided that the only intoxicating beverages which may be sold or consumed therein shall be pursuant to Chapter 104 of the Muncie Code of Ordinances entitled Designated Outdoor Refreshment Areas.
- Section 2 That this Ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor of the City of Muncie, Indiana, and such publication as may be required by law.
