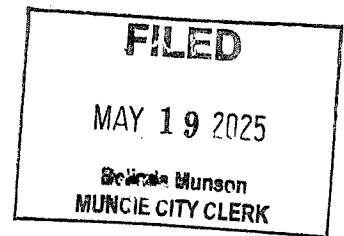


ORDINANCE NO. 21-25



**AN ORDINANCE OF THE CITY OF MUNCIE AMENDING PARKING
REGULATIONS NEAR THE VILLAGE
(Ball State University)**

WHEREAS, Chapter 80 of the City of Muncie Code of Ordinances contains certain Traffic Schedules which designate the traffic rules and parking restrictions for public streets within the City of Muncie; and

WHEREAS, Ball State University has developed a plan to provide more on-street public parking as part of new developments to The Village; and

WHEREAS, the requested changes require an Ordinance of the Common Council of the City of Muncie to become effective;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Muncie as follows:

Section 1: The following parking regulations are approved and shall be effective upon the installation of appropriate signage giving effect to the amendments:

- **Dill Street:** Within the one (1) block segment between Ashland Avenue and University Avenue, two-hour public parking shall be permitted between the hours of 6:00 a.m. and 6:00 p.m. Monday through Friday on the east side of the street. During all other times, parking on the east side of Dill Street within this one (1) block segment shall not be restricted or limited. Parking on the west side of Dill Street in this one (1) block segment shall not be permitted at any time.
- **Dicks Street:** Within the five (5) block segment between Beechwood Avenue and Gilbert Street, two-hour public parking shall be permitted between the hours of 6:00 a.m. and 6:00 p.m. Monday through Friday on the west side of the street. During all other times, parking on the west side of Dicks Street within this five (5) block segment shall not be restricted or limited. Parking on the east side of Dicks Street within this five (5) block segment shall not be permitted at any time.
- **North Street:** Within the two (2) block segment between McKinley Avenue and Martin Street, two-hour public parking shall be permitted between the hours of 6:00 a.m. and 6:00 p.m. Monday through Friday on the north side of the street. During all other times, parking on the north side of North Street within this two (2) block segment shall not be restricted or limited. Parking on the south side of North Street within this two (2) block segment shall be limited to the existing designated parking spots.

Section 2: Chapter 80, Schedule IV, Part I. No Parking Zones shall be amended as follows:

Section 3: Chapter 80, Schedule VI, Parking Restricted During Certain Hours shall be amended as follows:

North	McKinley Ave. to Dicks St.	Both	2 hr. parking 6:00 a.m. to 6:00 p.m. Monday through Friday

ADD

Dicks	Riverside and West Jackson	West	2 hr. parking 6:00 a.m. to 6:00 p.m. Monday through Friday
Dill	Ashland and University	East	2 hr. parking 6:00 a.m. to 6:00 p.m. Monday through Friday
Dill	University and North	Both	Metered Parking (Ord. No. 21-14)
Dill	Gilbert and Jackson	East	2 hr. parking 6:00 a.m. to 6:00 p.m. Monday through Friday
North	McKinley and Martin	North	2 hr. parking 6:00 a.m. to 6:00 p.m. Monday through Friday

Section 4: Chapter 80, Schedule XXII, Residents Exempt from Two and Three-Hour Parking Restriction – the Riverside Normal City Residential Neighborhood permit parking zone shall be amended as follows:

REMOVE

North St.	McKinley Ave.	Martin St.	North
Dill St.	Jackson St.	Riverside Ave.	East

Dicks St.	Jackson St.	Riverside Ave.	West

ADD

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side</u>
Dill St.	Jackson St.	University Ave.	East
Dill St.	Ashland Ave.	Riverside Ave.	East
Dicks St.	Jackson St.	Gilbert St.	West
Dicks St.	Beechwood Ave.	Riverside Ave.	West

Section 5: This Ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor of the City of Muncie. However, the amendments will take effect in accordance with Section 1.
