1. **Board of Public Works and safety, City of Muncie, State of Indiana, met in City Hall Auditorium, at 9:00 a.m.**
2. **Pledge of Allegiance**
3. **Roll Call Members Present:** Ted Baker – Lola Mauer/ABSENT – Linda Gregory
4. **Approval of the Minutes for June 6, 2025:** President Ted Baker entertained a motion to approve. Linda Gregory moved to approve minutes from the June 6, 2025 meeting as printed. Ted Baker provided the second. Questions called. Motion passed by voice vote.
5. **Register of Claims:** Craig Wright, City Controller, wished to bring attention to a few claims:

Questions called. Linda Gregory moved to approve register of claims of **290 Records** for a total amount of **\$409,005.32** as presented. Ted Baker provided the second. Questions called. Motion passed by voice vote.
6. **Street Closure Application, 4everlasting + Superator for a Basketball Tournament (7/11/25 – 7/13/25):** Tabled due to no representation being at the meeting. Additional insurance details are still needed.
7. **Noise Exemption Authorization, Colonial Crest Apartments Community Day Party:** Tyler Parson, Property Manager, and Laura Serserger, Regional Manager, from Colonial Crest Apartments presented the request for a noise exemption to host a community day party on June 14, 2025. The exemption was sought to permit a live band and PA announcements. Last year there were about 100 attendees and a car show is being added this year with hopes for nearly 200 attendees. The event is held within the confines of the Colonial Crest complex but outside people from Muncie and Yorktown are welcome to attend. No alcohol is expected and there will be no fireworks. The Police Chief has been informed of the event and organizers will have 14 to 16 volunteers monitoring as the day goes on. The purpose of the event is to bring the sense of community back. Discussion included emphasizing the importance of having contingency plans for potential issues like the presence of unapproved alcohol and having security in place. Questions called. Linda Gregory moved to approve the noise exemption authorization. Ted Baker provided the second. Motion passed by voice vote.


