1. **Board of Public Works and safety, City of Muncie, State of Indiana, met in City Hall Auditorium, at 9:00 a.m.**
2. **Pledge of Allegiance**
3. **Roll Call Members Present:** Ted Baker – Lola Mauer – Linda Gregory
4. **Approval of the Minutes for July 16, 2025:** President Ted Baker entertained a motion to approve. Lola Mauer moved to approve minutes from the July 16, 2025 meeting as printed. Linda Gregory provided the second. Questions called. Motion passed by voice vote.
5. **Register of Claims:** Craig Wright, City Controller, wished to bring attention to a few claims:
 - ✓ Page 13 \$24,501 & \$51,730.84 Flatland Resources CD FY 24 CDBG ADA sidewalk improvements.
 - ✓ Page 13 \$44,358.67 Muncie Public Library Historic Preservation Grant.

Linda Gregory noted this was the lowest claims amount seen in six years. Linda Gregory moved to approve register of claims of **214 Records** for a total amount of **\$258,528.49** as presented. Lola Mauer provided the second. Questions called. Motion passed by voice vote.
6. **A Resolution approving conveyance of real estate and quick claim deed (BOW Res. 1-25):** Previously Tabled, President Ted Baker explained that this resolution involves taking a very small sliver of land owned by the City of Muncie and turning it over to the Muncie Redevelopment Commission to be available for their use if needed. It doesn't really impact anybody at any time. City Attorney, Ben Freeman, was consulted and the matter was deemed good to go. When asked about the location, it was described as the 1700 block of N. Colson, possibly east of Tillotson and by Bethel. Linda Gregory moved to approve BOW Resolution 1-25. Lola Mauer provided the second. Motion passed by voice vote.
7. **Street Closure Application, Indiana Black Expo Chapter – Parade (August 2, 2025):** WaTasha Barnes Griffin appeared on behalf of the Indiana Black Expo Chapter to request a road closure for their annual August 2, 2025 parade which is part of their summer celebration weekend. The application included all appropriate signatures, insurance information, parade route, and details about security provided by Legacy Life Security. It was noted that the IBE has been organizing this parade for over 15 years. There are approximately 35 units participating in the parade, including physical units, walking and skate groups with participants coming from various surrounding communities and regions. The parade features lots of kids, music, dancing and candy. Linda Gregory moved to approve the street closure application. Lola Mauer provided the second. Questions called. Motion passed by voice vote.
8. **Adjournment:** There being no further business President Ted Baker adjourned the meeting at 9:07 a.m.
