## ORDINANCE NO. 28-25

## AN ORDINANCE OF THE CITY OF MUNCIE AMENDING THE TRAFFIC SCHEDULES SET FORTH IN CHAPTER 80 OF THE CITY OF MUNCIE CODE OF ORDINANCES

WHEREAS, Chapter 80 of the City of Muncie Code of Ordinances contains certain Traffic Schedules which designate the traffic rules and controls for public streets within the City of Muncie; and

WHEREAS, residents in the area of the Kenmore Neighborhood have requested that the speed limit for certain sections of McKenzie Street, Tyrone Drive, Shellbark Road, and Bittersweet Lane be reduced to make it safer for drivers, pedestrians and bicyclists; and

WHEREAS, the requested change requires an Ordinance of the Common Council of the City of Muncie to become effective;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Muncie as follows:

<u>Section 1</u>: Schedule XVII: Speed Limit Zones of Chapter 80 shall be amended by **ADDING** the following:
