MUNCIE CITY COUNCIL ORDINANCE NO. 29-25

AN ORDINANCE AMENDING CHAPTER 80 (TRAFFIC SCHEDULES) OF THE MUNCIE CODE OF ORDINANCES (UNIVERSITY AVENUE PARKING)

WHEREAS, it has been determined that it is necessary to update Chapter 80 – Traffic Schedules within the Muncie City Ordinances; and

WHEREAS, the City of Muncie desires to update said chapter as it relates to parking on University Avenue.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:

Section 1. That Chapter 80, Schedule V – Parking Time Limited is amended as follows:

DELETE THE FOLLOWING PARKING TIME LIMITED ON CERTAIN STREETS THEREFROM:

Section 2. That Chapter 80, Schedule XXII (1) – Riverside Normal City Residential Neighborhood is amended as follows:

Section 3. That Chapter 80, Schedule IV, Part I – No Parking Zones is amended as follows:

ADD THE FOLLOWING NO PARKING ZONE ON CERTAIN STREETS THERETO:
