- 4. Approval of the Minutes for October 15, 2025: Vice-President Lola Mauer entertained a motion to approve. Linda Gregory moved to approve minutes from the October 15, 2025 meeting as printed. Lola Mauer provided the second. Questions called. Motion passed by voice vote.

Linda Gregory moved to approve register of claims of **198 Records** for a total amount of **\$546,244.75** as presented. Lola Mauer provided the second. Questions called. Motion passed by voice vote.

- Ashton Land Surveyors, presented the dedication. Discussion involved a process for an administrative plat to divide properties owned by Mike Kilgore. The properly contained two existing houses that were already on two different parcels but the proposed division was in a different direction, necessitating a replat because the original boundaries were defined by metes and bounds. It was found that Main Street has been dedicated by 45 feet from the plat to the north. To bring the street up to the 50—foot requirement specified in the thoroughfare plan, an additional two and a half feet (2 ½ ft) of property needed to be dedicated on the north side of the property. The property on the west side, corresponding to Martin Street, had never been dedicated. To make Martin Street part of the dedication, they were dedicating 22 ½ feet (the half). These dedications were necessary in order to finalize the administrative plat. Linda Gregory moved to approve the right-of-way dedication. Lola Mauer provided the second. Motion passed by voice vote.
