BEING A RESOLUTION OF APPROVAL TO SUPPLEMENT AND AMEND THE TEXT OF THE CITY OF MUNCIE SUBDIVISION REGULATIONS REGARDING ARTICLE V. IMPROVEMENTS AND REQUIREMENTS

- WHEREAS, the State enabling act for planning and zoning empowers the City Council of Muncie, Indiana and the Board of Commissioners of Delaware County, Indiana to adopt Subdivision Regulations and also provides for amendments to said regulations as deemed necessary from time to time; and
- WHEREAS, the State enabling act also provides for amendments to the Subdivision Regulations to further promote the health, safety and general welfare; and
- WHEREAS, the current provisions require updating or clarification; and
- WHEREAS, the Delaware-Muncie Metropolitan Plan Commission has given legal notice of a public hearing for consideration of the proposed amendments in order to forward a recommendation regarding said amendment to the City of Muncie Subdivision Regulations as required by law; and
- WHEREAS, the Delaware-Muncie Metropolitan Plan Commission has given reasonable regard to the Comprehensive Plan, current conditions and the character of current structures and uses in each district; the most desirable use for which land in each district is adapted; the conservation of property values throughout the jurisdiction; and responsible growth and development.
- **NOW, THEREFORE, BE IT RESOLVED** by the Delaware-Muncie Metropolitan Plan Commission that the text of the City of Muncie Subdivision Regulations shall be amended, changed and supplemented according to **Exhibit A** as follows:
- **Section 1.** Supplement the subsection after SECTION 28-30 SIDEWALKS as SECTION 28-31 NATURAL FEATURES, and then recodify the remaining subsections.

The Delaware-Muncie Metropolitan Plan Commission hereby submits to you the following report on A RESOLUTION OF APPROVAL TO SUPPLEMENT AND AMEND THE TEXT OF THE CITY OF MUNCIE SUBDIVISION REGULATIONS REGARDING ARTICLE V. IMPROVEMENTS AND REQUIREMENTS

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission is charged, by state statute, with the preparation of amendments to the zoning ordinance in order to maintain a viable updated ordinance dealing with planning and zoning and said Commission has reviewed, revised and adapted certain standards for the City of Muncie, Indiana.

ARTICLE V IMPROVEMENTS AND REQUIREMENTS

SECTION 28-31 NATURAL FEATURES

In approving a proposed subdivision plat, the Commission shall consider the preservation of existing natural features contributing to the enhancement of a subdivision and its environs such as natural growth, watercourses, falls, beaches, and historic areas. Such features shall be incorporated in the design of the subdivision. Trees shall be preserved and shall be welled against grade changes. The subdivider shall provide at least one (1) approved shade tree per front yard; corner lots shall provide at least one (1) approved shade tree per street frontage. Such trees shall have a minimum diameter of not less than two inches (2" measured at forty-eight inches (48") above grade.

Section 2. That this Ordinance shall be adopted this 5th day of December 2025.

SECTION 28-31 NATURAL FEATURES

In approving a proposed subdivision plat, the Commission shall consider the preservation of existing natural features contributing to the enhancement of a subdivision and its environs such as natural growth, watercourses, falls, beaches, and historic areas. Such features shall be incorporated in the design of the subdivision. Trees shall be preserved and shall be welled against grade changes. Dear Commission:

I am writing to express my support for the proposed City of Muncie Subdivision Regulation amendment regarding natural features. In my role as Professor of Geography at Ball State University, I have developed an international reputation studying the connections between trees and urban society. Research around the United States has overwhelmingly demonstrated the following positives associated with urban trees:

- Most residents prefer to have trees in their yards and neighborhoods.
- Trees make our cities more livable, for example, by providing shade and dampening noise.
- Trees in cities provide important health benefits. For example, people report that they are
 happier and healthier when they can view trees from their windows. These benefits are
 medically measurable; viewing trees can lower blood pressure and reduce cortisols
 related to stress.
- Trees perform important environmental functions such as reducing stormwater runoff volumes, improving air quality, and moderating extreme urban heat during the summer.

The proposed amendment has two important components I wish to emphasize. First, I agree that it is wise to preserve existing trees when possible, because mature trees provide the most benefits. Second, it is crucial to plant new trees in subdivisions to enhance the long-term livability of those neighborhoods and of the city as a whole.



Lorey,

At the Muncie Urban Forestry Committee meeting of October 18, 2023, the committee voted unanimously to support the proposal to revise Muncie Subdivision ordinance requiring that trees are to be planted in the public right of way of new subdivisions in the City of Muncie. The committee reviewed and supported the draft ordinance revision (section 28-31 Natural Features) that you provided and added further endorsement by noting that new subdivisions in Delaware county already have this requirement.

In the matter of bonding for tree installation, the committee suggests that this be filed with the Board of Public Works and Safety.

We understand that a focus group will be formed by the Planning Commission to discuss this proposed ordinance revision. I am willing to serve on this committee and will also seek an alternate to represent the committee if needed.
