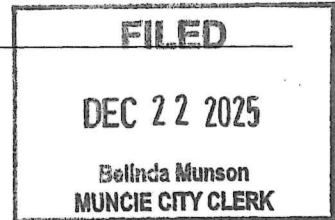


**MUNCIE CITY COUNCIL  
ORDINANCE NO. 5-26**



**AN ORDINANCE AMENDING CHAPTER 80 (TRAFFIC SCHEDULES)  
OF THE MUNCIE CODE OF ORDINANCES (WESTVIEW ELEMENTARY)**

**WHEREAS**, it has been determined that it is necessary to update Chapter 80 – Traffic Schedules within the Muncie City Ordinances; and

**WHEREAS**, the City of Muncie desires to update said chapter as it relates to parking near Westview Elementary School.

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA, AS FOLLOWS:**

**Section 1.** That Chapter 80, Schedule XX: No Stopping, Standing or Parking is amended as follows:

**ADD THE FOLLOWING NO STOPPING, STANDING, OR PARKING TO THE STREETS IDENTIFIED HEREIN:**

STREET	RESTRICTED ZONE	SIDE	TIME LIMIT
N. Greenbriar Rd.	W. Westview Blvd. to W. Gilbert St.	Both	7 a.m. – 9 a.m. & 2 p.m. to 4 p.m.
N. Greenbriar Rd.	W. Gilbert St. to 300 ft north of W. Gilbert St.	Both	7 a.m. – 9 a.m. & 2 p.m. to 4 p.m.
N. Wildwood Ln.	W. Gilbert St. to 300 ft north of W. Gilbert St.	Both	7 a.m. – 9 a.m. & 2 p.m. to 4 p.m.
N. Brentwood Ln.	W. Gilbert St. to 300 ft. north of W. Gilbert St.	Both	7 a.m. – 9 a.m. & 2 p.m. to 4 p.m.
N. Forest Ave.	W. Gilbert St. to 300 ft. north of W. Gilbert St.	Both	7 a.m. – 9 a.m. & 2 p.m. to 4 p.m.

**Section 2.** This Ordinance shall be in full force and effect upon its passage by the Common Council, its approval by the Mayor of the City of Muncie, and its publication in accordance with the law.

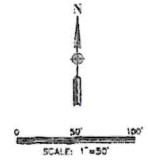

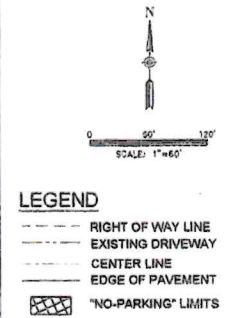
