

6. **Design Build Contract with FlatLand Resources for the design and construction of the Phase III Prairie Creek Trails:** City Engineer Adam Leach presented a design-build contract for the construction of Phase III of the Prairie Creek Trails. The funding will be supported by a DNR grant with a 66% DNR/33% City split. The total project cost is approximately \$370,000. The Parks Board has approved the project, and Indiana American Water has given its blessing for the trail installation. An RFP was proposed and the design committee made their selection. The project was slightly delayed due to the coordination process with Indiana American Water. Linda Gregory moved to approve the contract. Lola Mauer provided the second. Questions called. Motion passed by voice vote.
7. **Street Closure Application, Muncie Mission Ministries (2/21/26):** Bob Scott, Muncie Mission Ministries, requested approval for street closures related to the 22nd annual "Walk a Mile in My Shoes" event. The walk will proceed down Walnut to 8th Street, then from 8th Street to Liberty Street to the Mission. This is the Mission's largest annual fundraiser. Lola Mauer moved to approve the street closure application. Linda Gregory provided the second. Questions called. Motion passed by voice vote.


8. **Adjournment:** There being no further business President Ted Baker adjourned the meeting at 9:06 a.m.


