1. Board of Public Works and Safety, City of Muncie, State of Indiana, at 9:00 A.M. President Gregory called the meeting to order.
2. **Pledge of Allegiance**
3. **Roll Call Members Present:** Linda Gregory, Ted Baker, Jerry Wise
4. **Board of Works Minutes for July 1 2020:** President Gregory entertained a motion. Ted Baker moved to approve minutes from the July 1st, 2020 meeting as printed. Jerry Wise provided the second. Motion passed by voice vote.
5. **Register of Claims:**

Trent Conway, City Controller commented there are a few items I would like to point out on this week's claims. You will see several large health insurance claims. This is to transfer the money to our health insurance surplus fund. The total of these health insurance claims are roughly \$2.5 M. You will also see several claims for Fifth Third Insurance which is for our annual premium for Workers Comp. Invoice was roughly 70K. Page 3 there is a claim for \$101K which is for our IT consulting. Top of page 7 there is a claim for \$200,000 which is the city's contribution to the 911 Center.

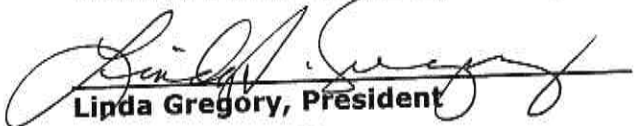

McKinley Avenue. Close southernmost west bound traffic lane during demolition of adj. street to ensure public safety. Start Date: July 20, 2020 End Date: July 29, 2020, BSU students move back to campus August 1, 2020. President Gregory requested that the newspaper be notified of the closure to add an article in the paper. President Gregory entertained a motion. Ted Baker moved to approve McKinley Avenue closure as presented. Jerry Wise provided the second. Motion passed by voice vote.
