- 2. Pledge of Allegiance
- 3. Roll Call Members Present: Linda Gregory, Ted Baker
- 4. Board of Works Minutes for October 28, 2020: President Gregory entertained a motion to approve the minutes from last week. Ted Baker moved to approve minutes from the October 28, 2020 meeting as printed. Linda Gregory provided the second. Motion passed by voice vote.
- Fegister of Claims: Trent Conway, City Controller commented there are a few claims I would to bring to the Board's attention today, first one is on page #5 Delaware County Auditor \$200,000. Third quarter payment for the 911 center for agreement the city has with the County. Page #11 Heartland Ambulance Service LLC \$99,500 this is the monthly billing for them to provide paramedics for the City of Muncie. Page #20 Hardest Hit Fund Blight Elimination Program, which is now complete, but we still see final invoices come in for that program.

Ted Baker asked a question on Page #8 Ascension St. Vincent Public Safety \$10,854.86 Trent explained this is for some of the medical test that the Police Officers have to go through for pension board. Page #16 Pavement Solutions, Inc. \$115,166.45 Brian Stephens-Hotopp, City Engineer reported that they were doing crack sealing for road restoration work for the Street Department.
