- 5. Register of Claims: Trent Conway, City Controller reported he wanted to bring a few things to the Board's attention this being my last meeting. Page #3 Board of Works, Other Services & Charges there this an expense for the Muncie Public Library \$5,012.34 Library's did not get COVID grant money from the State. Rather the State giving them money directly they asked the Library has to work with their financial body, which used to be the county and is now the city. Therefore, they make requests through us. Page #6 Center Township Revenue, Other Services & Charges Heartland Ambulance Service \$99,500.00 this is the monthly bill for Heartland to provide us with Paramedics. The last item I want bring up is the expense for the Martin Street Greenway Connector that Brian was doing, we had to split those out between three different funding's from a Bond, that BSU gave us grant and the remaining balance came out of the wheel tax.
