**A RESOLUTION OF THE CITY OF MUNCIE EXPRESSING SUPPORT FOR
DESIGNATION OF MARCH 14TH AS "PI DAY" IN THE CITY OF MUNCIE**

Whereas, Pi is a fundamental mathematic constant that has been the area of study throughout history and is central to the teaching of mathematics and science;

Whereas, mathematics and science are critical to the education of students in the City of Muncie;

Whereas, the State of Indiana scored a 286 on the 2019 National Assessment of Educational Progress, a number above the national average of 281 with 73.38% of students at or above basic proficiency;

Whereas, the City of Muncie must reinforce mathematics and science education for all students to prepare them for the trials of the 21st century;


Whereas, Pi can be an appealing way for a student to learn about statistics to attract them to the studies of mathematics and science;

Now, therefore, be it resolved by the common council of Muncie, Indiana as follows:

1. Supports the designation of "Pi Day" for March 14th, and its celebration around the city;
2. Acknowledges the importance of math and science programs within the city;
3. Encourages all educators in the City of Muncie to observe the day with suitable activities to teach students about Pi while engaging them in the studies of math and science;
4. Encourages parents to engage their children about Pi along with math and science broadly.
