ORDINANCE NO. 34-21



**AN ORDINANCE FOR ADDITIONAL APPROPRIATIONS (FIRE DEPT – EMS)**

**WHEREAS**, the City of Muncie has used approximately 86% of the Fire Department – EMS’ budget for “other supplies;”

**WHEREAS**, the City of Muncie Fire Department requests additional appropriations in the amount of \$125,000 for its Fire Department-EMS-other supplies budget; and

**WHEREAS**, it has been determined that it is necessary to make certain amendments within the Fire Department – EMS fund budget to reflect these changes;

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:**

**Section 1.** The following additional sums of money are hereby appropriated for the purposes specified, subject to the laws governing the same. Fund 24 is titled “EMS.”
