ORDINANCE NO. 45-21

**AN ORDINANCE FOR ADDITIONAL APPROPRIATIONS
(ECONOMIC DEV INCOME TAX CREDIT)**

WHEREAS, the City of Muncie has expended or committed the amount appropriated for 2021 from Fund 2411 Economic Dev Income Tax CREDIT ("Fund");

WHEREAS, the City of Muncie carried over a balance of \$625,608.44 in the Fund from 2020; and

WHEREAS, it has been determined that it is necessary to make an additional appropriation from the Fund;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:

Section 1. The following additional sums of money are hereby appropriated for the purposes specified, subject to the laws governing the same. Fund 2411 Economic Dev Income Tax CREDIT:




