PARTNERSHIP AGREEMENT October 2021

THIS PARTNERSHIP AGREEMENT is made by and between Muncie Downtown Development Partnership (MDDP), a not-for-profit organization organized under the laws of the State of Indiana and the Muncie Redevelopment Commission through its Executive Director, this 16th day of October 2021.

Whereas, MDDP is a 501(C)3 organization supported by public and private partnerships. MDDP exists to create a downtown environment that results in sustainable economic and cultural growth.

Whereas, the Muncie Redevelopment Commission has a strong commitment and desire to maintain and improve upon the downtown area.

Whereas, the Muncie Redevelopment Commission desires to have a central location or one contact regarding the promotion, development, maintenance and viability of the downtown area.

Whereas, to provide a central location for their activities, the MDDP and the Muncie Redevelopment Commission have entered into this Partnership Agreement.

Whereas the MDDP and the Muncie Redevelopment Commission have a strong desire to increase tax revenue (TIF) in the downtown district.

NOW, THEREFORE, the parties hereby agree as follows:

- 1. <u>Purpose:</u> The purpose of this Partnership Agreement is to promote, develop, manage and market the downtown area.
- 2. <u>Term:</u> The term of this Partnership Agreement shall be for a period of one (2) years commencing on the 1st day of January 2022 and ending on the 31st day of December 2023.
- 3. <u>Scope of Agreement:</u> The MDDP shall fulfill the following general duties and responsibilities:
 - a. MDDP shall make their staff available to assist in economic development recruitment efforts for the Muncie Redevelopment Commission in the downtown area.
 - b. MDDP shall build and maintain a comprehensive database of available housing and commercial space for the benefit of the MDDP and the Muncie Redevelopment Commission in marketing the downtown area. This database shall include square footage, amenities, costs and contact information for the spaces in the downtown area

- c. MDDP shall organize and implement Downtown/City marketing campaign to further economic development.
- 4. <u>Compensation:</u> The MDDP shall be compensated as follows: the Muncie Redevelopment Commission shall pay to the MDDP a total of \$80,000 for 2022 through 2023 in accordance with the following schedule:

\$40,000 due by January 1, 2022 \$40,000 due by July 1, 2022 \$40,000 due by January 1, 2023 \$40,000 due by July 1, 2023

- 5. <u>Termination</u>: This Partnership Agreement may be terminated as follows:
 - a. The Muncie Redevelopment Commission and MDDP may terminate this agreement upon the mutual agreement of the Muncie Redevelopment Commission and MDDP.
 - b. This Agreement may be terminated by either party upon giving the other party a written notice that a material breach of this Partnership Agreement has occurred. Upon receipt of such notice, the party who receives the notice shall have a period of forty-five (45) days to cure the material breach, or in the event such breach cannot be cured within such 45 day period, the party who received the notice shall have commenced to cure such breach within 45 days and diligently continued thereafter to attempt to cure such breach or this Partnership Agreement shall terminate. For purposes of this Partnership Agreement a "material breach" shall occur if party (i) makes a general assignment for the benefit of its creditors, applies for or consents to the appointment of a receiver, trustee, or liquidation of all or a substantial part of its assets, files a voluntary petition in bankruptcy, has an involuntary petition in bankruptcy filed against it (which is not released within ninety (90) days), or fails to pay its debts and obligations as they mature in accordance with normal business practices; (ii) fails to make any payment when due under this Partnership Agreement; (iii) makes an unauthorized assignment or transfer of this Agreement; or (iv) fails to make good faith efforts to perform its obligation under this Partnership Agreement.
 - c. By either party, for convenience, upon no less than 180 days advance written notice to the other party.
- 6. <u>Notices</u>: All notices to or upon the respective parties hereto to be effective shall be in writing and shall be deemed to have been duly given or made when deposited with an overnight (or next business day) courier service, when sent, addressed as follows, or to such other address as either party hereto may hereafter specify in writing to the other party:

- 7. <u>Governing Law</u>: This Agreement shall be governed by and construed in accordance with the laws of the State of Indiana.
- 8. <u>Assignment</u>: Neither the Muncie Redevelopment Commission nor MDDP may assign this Partnership Agreement or any of the rights and duties expressed herein without the express written consent of the other party.
- 9. <u>Entire Agreement</u>: This Partnership Agreement constitutes the entire agreement between the parties hereto with respect to the matters herein contained and any agreement hereafter made shall be ineffective to effect any change or modification, in whole or in part, unless such agreement is in writing and signed by both the City of Muncie and MDDP.
