

MUNCIE CITY COUNCIL ORDINANCE 47 -21

AN ORDINANCE AMENDING ORDINANCE 28-20 FIXING THE MAXIMUM SALARIES OF EACH AND EVERY APPOINTED OFFICER, EMPLOYEE, DEPUTY, ASSISTANT, DEPARTMENTAL AND INSTITUTIONAL HEAD OF THE CITY OF MUNCIE, INDIANA, INCLUDED HEREIN FOR THE YEAR 2021

WHEREAS, I.C. 36-4-7-3 requires the Mayor of the City of Muncie, Indiana, to fix maximum compensation for appointed officers and employees of the City of Muncie, Indiana, and

WHEREAS, the Council has previously adopted a maximum salary level for each labor grade in the City in Ordinance 28-20; and

WHEREAS, there is a need to increase the maximum hourly wage of Part-time/labor employees; and

WHEREAS, the funds for such salaries are to be provided for in the 2021 City Budget, and other such sources as may be specified by the Common Council;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA, THAT:

SECTION 1. Ordinance 28-20 is hereby amended as specifically provided herein.

SECTION 2. The maximum hourly wage for all Part-time/labor employees shall be \$15.00 per hour.

SECTION 3. The first payday under this ordinance will be September 15, 2021.

SECTION 4. This ordinance shall be in full force and effect from and after its approval by the Mayor of the City of Muncie, Indiana, and such publications as are required by law.
