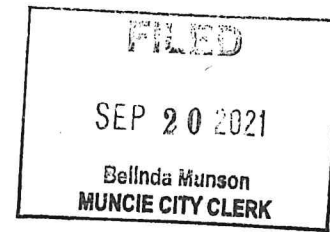

**A RESOLUTION FOR TRANSFER OF APPROPRIATIONS (FIRE DEPARTMENT)**


