The developer and owner of that project are looking to sell it and per requirements through HUD to kind of underwrite the new owner under this instance the affordability period for the Home funds only last through the beginning of December. So we are just making sure that the new owner has the capacity and the funds to keep it affordable through or program for less than two months. President Gregory asked the name of the new owner. Zane responded University Park Residential LLC. President Gregory entertained a motion. Ted Baker moved to approve Acquisition Agreement as presented. Lola Mauer provided the second.
