COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA

RESOLUTION APPROVING INTERLOCAL AGREEMENT FOR A JOINT EMERGENCY DISPATCH AND COMMUNICATION CENTER

WHEREAS, the City of Muncie, Indiana (the "City) previously entered into an Interlocal Agreement with Delaware County, Indiana (the "County") for operation of a joint emergency dispatch and communications center for certain emergency response agencies located within the County; and,

WHEREAS, the prior Interlocal Agreement was executed in 1984 and amended on several occasions; and

WHEREAS, the parties desire to continue to work together and operate a joint emergency dispatch and communications center for emergency response calls and dispatch; and

WHEREAS, the Common Council of the City (the "Council") has reviewed said Interlocal Agreement; and

WHEREAS, it is the intent of the Council for the City to continue to operate a joint emergency dispatch and communications center for emergency response calls and dispatch with the County, as evidenced on Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:

<u>SECTION 1.</u> The City Council for the City of Muncie, Indiana hereby approves the Addendum to Inter-local Agreement, attached hereto as Exhibit A for the purpose of operating a joint emergency dispatch and communications center for emergency response calls and dispatch with the County.

SECTION 2. This Resolution shall be in full force and effect from the date of its adoption by the City Council for the City of Muncie, Indiana.

ADDENDUM TO INTER-LOCAL AGREEMENT

WHEREAS, the parties have previously operated a joint emergency dispatch and communication center for certain emergency response agencies located within Delaware County pursuant to an Inter-Local Agreement executed in 1984 and amended on several occasions; and

WHEREAS, the parties continue to desire to work together and operate a joint emergency dispatch and communications center for emergency response calls and dispatch; and

WHEREAS, in order to work together for the efficient and prompt delivery of emergency communications services to all public safety officers and departments in the County and City, the City and County have agreed to execute an addendum to the current inter-local agreement pursuant to Ind. Code § 36-1-7 el. seq clearly setting forth the rights and obligations of each with respect to the management, operating and financing of the joint emergency dispatch and communication center; and

NOW, THEREFORE, the parties hereby amend the Inter-Local Agreement as follows:

- 1. Term: The addendum term of this Agreement shall be for an additional one (1) year commencing on the 1st day of January, 2022 and ending on the 31st day of December, 2022.
- 2. <u>Current Inter-Local Agreement:</u> All other terms and conditions of the original Inter-Local Agreement dated January 1, 2020, shall remain in full force and effect during the addendum term through December 31, 2022.
