

Program Year 2022 Community Development Block Grant and HOME Investment Partnership Funding

The City of Muncie Community Development Office (CD) will be holding several meetings related to the Program Year (PY) 2022 Community Development Block Grant (CDBG) and Home Investment Partnership Program (HOME) programs, funded by the U.S. Department of Housing and Urban Development (HUD). CD anticipates resources in the amount of \$1,321,600 (or less) in CDBG funds and \$513,000 (or less) in HOME funds for PY 2022. Allocations have not been received from HUD at the time of this publication

PUBLIC HEARING

CD will hold a public hearing to solicit public comment on community needs and how these needs might be addressed within the CDBG or HOME programs and accordingly in the PY 2022 Action Plan. The public hearing will be held on Wednesday 12/08/21 at 1:00 PM in City Hall Auditorium. The meeting will also be livestreamed via the City of Muncie Facebook page.
