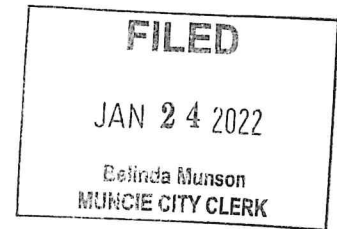

AN ORDINANCE FOR ADDITIONAL APPROPRIATIONS (BUILDING COMMISSIONER)
