### Approval of minutes:

Deb Mace made a motion to accept the March 16, 2021 meeting minutes as presented, Dea Bell seconded the motion. Motion to accept meeting minutes as presented is carried by voice vote.

#### Business from Chief Sloan:

Chief Sloan began by reading a commendation letter presented from Lt. Ryan Trissel to Officer Ron Miller for his unusual bravery, outstanding police action and other meritorious acts.

Deb Mace seconded the motion. Motion to appoint Dawson Schmidt to the Muncie Police Department is carried by voice vote.

Chief Sloan asks that the next applicant on the current hiring list be appointed to the Muncie Police Department. The next name on the current hiring list is Joseph Schafer. Chief Sloan asks that Joseph Schafer be appointed to the Muncie Police Department. Mike Mueller made a motion to non-conditionally appoint Joseph Schafer to the Muncie Police Department pending the completion of PERF and other required background checks. Dea Bell seconded the motion. Motion to appoint Joseph Schafer to the Muncie Police Department is carried by voice vote.

Based on combined scores and background investigations, Chief suggests terminating the current hiring list. Mike Muller made a motion to terminate the current the hiring list. Deb Mace seconded the motion. Motion to terminate the current hiring list is carried by voice vote.

#### Facts of the situation:

On February 26, 2021 at approximately 1228 HRS Officer Ron Miller arrived on scene of a subject refusing to leave/ domestic issue at 1200 N Granville Ave. Once being let into the residence Officer Miller was immediately met by Gregory Goul who was armed with a kitchen knife in his hand and was threatening to use the knife. Officer Miller did an outstanding job maintaining his composure and trying to establish rapport with Gregory. Gregory kept trying to escalate the situation himself and Officer Miller would not allow that to happen. Officer Miller kept talking calmly with Gregory and trying to de-escalate the situation. Officer Miller kept this up while being the only officer on scene and with Gregory's elderly parents in the house. Officer Miller was able to keep Gregory calm long enough for other officers to arrive on scene and Gregory being taken into custody with less lethal options being used. Gregory appeared to be trying to commit suicide by police officer and due to Officer Miller's calm composure and de-escalation of the situation Gregory is still alive and was taken to get assistance

The City of Muncie suffered four homicides during the month of February 2021. Three individuals were killed in a single event and a fourth individual was killed in a separate event days later. The Muncie Police Department's Criminal Investigations Division is comprised of only 9 detectives who investigate cases and 2 crime scene investigators who process crime scenes. It should be noted the occurrence of four homicides in any given month is extraordinary for the City of Muncie and the Muncie Police Department.
