

Muncie Park & Recreation Board Meeting

April 19, 2022 6 p.m.

City Hall Auditorium

- 1. CALL TO ORDER-** Brad Marshall called meeting to order at 6:00p.m.
- 2. PLEDGE OF ALLEGIANCE** – All stood for the Pledge
- 3. ROLL CALL-** Present were President Brad Marshall, Shannon Powers, Mark Ervin James Lutton and Chandra Parks.
- 4. APPROVAL OF MARCH 15TH BOARD MINUTES-** Vote was taken by all Board members present. Motion carries. Motion approved by all members present.
- 5. SUPERINTENDENT REPORT – Carl Malone, Superintendent**
 - Sanitation Renovation was delayed two weeks due to the wrong address being given to Xfinity which made them unable to do the install. We are looking to move the latter part of April. We are moving some furniture over and the phone lines should be transferred this week. We will be getting the security and other items taken care of so we can operate as a department.
 - Tuhey Pool- we have spoken with Gerrett at Buddenbaum Moore and we have a pre-opening date of May 9th for them to come take a look at and prepare us for opening on Memorial Day. The splash park should be ready within a couple of days. I spoke with the Program Director and he indicated the pads should be in tomorrow. The Mayor wanted to be open the last few weeks but the weather has been bad so we are hoping we can start them up this weekend.
 - American Clean & Seal was in to work on the pool area. In the past we've had issues with slippage which was a safety concern so they put an epoxy seal coat on our existing concrete and we're hoping that problem is resolved. We look forward to having a safe area for the kids to play this summer.
 - McCulloch Park – Richard Ivy isn't here at the present time but The City of Muncie, Ball State and The Cal Ripken Foundation entered into an agreement to renovate McCulloch. It's going pretty good as they have been working six and seven days in the rainy weather to get the project going. I've been going out

through the week to answer any questions I can to help with moving the project along. It is still on target for sometime in June to be completed.

- Riverview Park has had some setbacks due to permitting. The City has done their part with submitting the paperwork and they are waiting to hear back from the State. I've had a couple of conversations with the neighbors and have provided them some updated information on the park. The main concerns they had were the start date and completion date which we couldn't give them a completion date until we know the start date. We do know the paperwork has been submitted and we are waiting for the state to let us know when we can begin.
- Westside Park/Skate Park – we do know there is \$300,000 set aside from ARP funds to help support the project and I think there is an additional \$150,000 still to be raised. Once those funds are brought in we will begin that project hopefully this year.
- Park staff has been doing small projects still working inside when the weather does not allow us to be out. We've started some mowing but mainly we have been moving and renovating the new building on Centennial in hopes we can be in there in a couple of weeks and be back outside mowing.

Brad inquired about the bathroom situation & water being turned on at the parks as people are starting to be outside since the weather is getting warmer. Carl stated they tried to turn the water on McCulloch but had some leaks we are currently fixing but we should have the water at all the parks should be on by Thursday. Thomas Park has been hosting baseball and they have requested water as well. Carl stated the Mayor would like to have the splash parks open as well. Brad inquired if Cooley and Halteman would be up as well. Carl stated we have been in contact with the water company so we can finish up repairs at Halteman.

6. PRAIRIE CREEK REPORT – Ashley Wright & Dustin Clark

Ashley stated they have been very busy at Prairie Creek and Dustin commented that the campground opened on time and they've started to mow. Ashley stated everything is pretty much going as planned. The docks may be a little behind but they have time to catch up as they have a few extra employees they don't normally have. Dustin said they added a few extra interviews and hired two additional people. Ashley stated they have extra grounds crew that can help with the frames. It takes about 6 per frame and only 2 for the docking. She posted pictures of the workers in the cold water yesterday putting the piers in.

Dustin said the Street Department should get a shout out. Adam the new engineer and Donny Wright loaned them a ToolCat that will help things go faster. Ashley also thanked

Carl and the Parks Department for running trash in the campground as that was a big help since their trash truck is down.

Ashley reported there are about 9 campsites and less than 20 docks available. The lottery received 249 campsite entries and 375 dock entries.

Brad inquired if there was a target date on either of the lotteries yet and Ashley said they had to get rid of a few docks to install the new ADA accessible piers. The dockholders being displaced will get to choose first out of what is available and after there should be about 20 docks available for the public after the moves. Then there will be a switch day for people who already have docks and want to move and then we can do the actual lottery. For the campsite we haven't been letting anyone move. We let one camper move that had some prior documented issues. Seeing how we didn't know there would be this level of interest and didn't do a switch list. We've had people ask lately but those who called two months ago were told they couldn't, we are trying to make it fair so this year they won't be able to switch but we can do a switch list next year. Dustin interjected they can still transfer amongst themselves and the rest will be available to the public on the lottery list. Ashley stated they may see more openings in the campgrounds as we don't let anyone transfer their sites when they sell their campers. She believes the current campers that want to switch to a spot on the water may be happy as they now have an option which they didn't have before as people would transfer their site to whoever bought their camper. In the end this change is more fair to the existing campers.

Shannon asked how everything went with the contract and if everyone signed and submitted it by the due date. Ashley stated they added the addendum which clarified a few points including changing power wash to clean, insurance for golf carts and elimination of turn signals on golf carts. Other than that everything went well.

Shannon inquired if there was another meeting scheduled with the campers so they feel they have more access to them. Ashley stated they do not but their door is always open. She has spoken to a few of them that have reached out and some have expressed wanting to put a group together to help put on activities and we would facilitate that as we don't have the staff to do it. We will be moving forward with that so we will be having more meeting that are camper led. Shannon said may they could meet with the two of them (leadership) and work collaboratively as it seemed from the last two meetings that was one of their main concerns. Collaboration and communication. Ashley stated the communication issue goes both ways and Dustin interjected they would make themselves more available as well.

Shannon asked if they wanted the Board to help facilitate or come up with a schedule so they are present for them as well. To just let them know and she would volunteer her

time. Ashley invited all the Board Members to come down to walk the grounds with them.

Brad stated he spent about an hour last weekend walking the ground with Dustin and it was an experience. He saw many positive things and some things we could work on with the campers to make improvements. Dustin stated there were a lot of positive interactions which started with clarification and ended with very positive comments.

Brad stated he forwarded everyone the surveys to read and there was a lot of positive feedback there. And some feedback and request for things that are already in the works to be addressed.

Shannon stated she would like to set up a long term plan to address the electrical needs of the campers. Ashley stated they have had a meeting with AEP to see what can be worked out. Dustin stated there are planned new revenue streams to go towards that and once that happens and is upgraded we can take new funds from there and put into the next location until they are done with the entire site. There is a road map to success that has been established and if we follow it we will see the problem can be self correcting. Shannon stated she would like to hear that plan at a future meeting. Just the timeline and what the plan is. Dustin offered to set up one on ones with anyone from the Board to go through each phase of planning and funding.

James stated he went out to talk to Dustin and Ashley and they are really willing to sit down and share anything they have. They are really working hard and the staff should be thanked as they aren't treated very nice by some of the people that come in and people don't understand the workers are just following protocol.

Brandon asked with the increase of events at Prairie Creek how will open swim requests be handled. Dustin responded that he and Ashley have been talking to a past BSU professor and swim coach that now trains open water swimmers for triathlons and were collecting info on what she does that is safe. She is a spotter that goes out in a kayak and with a buoy. Once we get all the safety issues we will set up a protocol list of things they can do on their own and what we can do to aid or assist. Ashley stated one of her concerns are the new boaters that don't pay close attention and she worries swimmers won't be seen which is why a spotter is very important. Dustin also stated they are looking at having a designated course for open swimmers

Shannon stated she knows the BSU professor and believes one thing she does that will help is she only trains in the early morning. Dustin & Ashley agreed the time of day is very important. They may be permitted at certain times from certain locations and if

there are more than four of them they will need to register at the office. They are working through it to come up with protocol.

1st Annual Triathlon is requesting the use of Prairie Creek beach parking lot on August 20, 2022 all day starting at 8 AM. They have an expected attendance of approximately 200 participants. Mr. Ruppel was directed to discuss the event with the Sheriff's regarding road closure.

Brad reminded them to ensure campers are notified well in advance of the event as that is something mentioned in the surveys.

Vote was taken by all Board members present. Motion carries. Motion approved by all members present.

Army Recruit Training Qualification is requesting the use of Prairie Creek beach and trails on May 21, 2022 from 12 – 6 PM for their training qualifications. They are expecting between 65 – 85 participants. There will be no need for closure of the beach or roads.

Vote was taken by all Board members present. Motion carries. Motion approved by all members present.

Ball State ROTC is requesting the use of Prairie Creek multi-use trails on April 22, 2022 from 5 am – 7:30 AM for their training.

Vote was taken by all Board members present. Motion carries. Motion approved by all members present.

Adult Prom is requesting the use of Community Building on July 30, 2022 from 4 PM – 12 AM. They are expecting about 60 people which will consist basically of campers that are 21 years old and up. We had them pay for the building as they will be having outside people as well.

Voting was tabled until we could confirm if alcohol will be served, if they have insurance and if they will have security.

8. PARK PROGRAMMING – George Foley, Programs Director

It has been very busy at the Parks Department and in programming. We started interviewing kids for the Summer Youth Mentor and Employment Program and I would like to thank some ladies for helping with interviews. We have interviewed about 170

youth in about a week and a half. Nikki Eckerson, Krista Garrett, Anitra Montgomery, Kassandra Woods, Monique Vargas and Tamica Crumes volunteered in the evenings from 4 – 7 pm to conduct interviews. The kids did a good job with the interviews so it will be tough to pick just 100. The good thing is this year they will work two days a week with mentoring on Wednesday. Our hub this year will be Northside Middle School as Central is having their cafeteria remodeled. Thrive will be working with us to open bank accounts for the workers who prefer direct deposit. They will also issue a credit to the accounts after their first paycheck. The program will last six weeks. All the staff has been hired so we are ahead of schedule in that regard.

Youth Soccer is going on right now with **Friends of Conley** and Richard Ivy. We signed up about 200 kids and would like more coaches for the teams.

Flag Football will take place this summer. It will be for grades K – 6 and is in partnership with John Frank and 3rd and 11. We will have a combine first at Muncie Central then draft players to the teams. They will play every Tuesday for four weeks in June.

Shannon inquired if they needed coaches for the football program and George stated they do and they have funding to pay referees as well. So if there are any Ball State students that want to referee there are funds to pay them. Shannon inquired how young can the coaches be (age) for the program and George replied that it would depend on their maturity level.

I've talked to the Muncie Central Coach and he is excited about the program and he will be helping out and may bring some players also.

Baseball Programs – We've talked to Southside and have started renovating the softball and baseball fields thanks to the O'Connors and Tom Terrell and we will be having the youth playing baseball this summer. We are currently using Thomas Park for baseball.

We have a lot of activities lined up at the parks this summer.

Lifeguard Certification Program for people ages 16 and up. It is free and starts this weekend. Anyone can sign up although the grant specifies youth of color.

James asked if they were having a good response to the lifeguard program and George responded he believes they have 8 people signed up the certification and a lot of people signing up to be lifeguards at Tuhey Pool. They have put the word out and will continue to as there is another class in May that they can still sign up for. Shannon stated they are also recommending they sign up for Prairie Creek Beach as well.

Brad inquired if there were any other events to present and George stated he had no other events at the time.

9. TUHEY POOL NEW CHEMICAL SYSTEM – Carl Malone, Superintendent

We had a meeting with Shannon Powers, Richard Ivy, YMCA and Hawkins Group looking for an opportunity to improve the pool system at Tuhey Pool. We have been using sodium tablets for the past 15 years and are looking to change to using the liquid instead. One of our partners, YMCA currently uses it. They will be maintaining our pool for us and believe there will be a cost savings by switching over. After reviewing our records we spent over \$17,000 on chemicals for the pool last year and we can possibly save \$3,500 - \$4,000 by changing the chemical process. Hawkins will assist in maintenance, equipment and repairs at no cost. We are asking for the Board to be opened as we create cost savings. We will come back later asking for support on adding line items for next year to have funds in the budget for maintenance. Right now everything is coming out of the Parks budget and with that I will allow Mr. Ivy to speak about it.

Deputy Mayor, Richard Ivy apologized for his low voice as he lost his voice since soccer started this weekend and he was there for every game. We have over 200 kids signed up and he tries to attend the first two practices for each team to answer questions from the parents. I was part of the meeting regarding Tuhey and they went into great detail about the system we currently have and how they could retrofit it to be more user friendly for the staff and decrease costs in the process. The change will also lower safety risks as the tablets have an ammonia gas that comes off them and getting them in at the right PH balance. We lost 21 days last year because of the lack of proper balance. He thinks this is a good decision as Hawkins will be handling the maintenance and there will be minimal staff interference and they will also handle replacement of parks. The City of Muncie supports the direction Carl is trying to take the pool to better serve the community. He thanked Dr. Powers and Hawkins for their efforts in the process and stated that if for any reason we wanted to go back to the old system we could, but he doubts we will want to.

10. BURT WHITELEY TRUST – Carl Malone, Superintendent

This was a fund set up by the Burt Whitely family to make improvements and upgrades to McCulloch Park. We are currently making upgrades and are asking the Board to become familiar with the trust if they already haven't as we would like to make playground upgrades which would fall under beautification. The Board will have to decide what falls under beautification and at a later dated to give us a go ahead to move forward on upgrades. The ball diamond is currently being upgraded and we have the

two playgrounds as well. One is in good shape and the second is in very bad condition and we would like to replace and upgrade the playground with safe fall surface and playground equipment as well. If you have any questions after you read it, we can do a Zoom or have a meeting.

Shannon asked where the information regarding the trust is and Carl stated it was in our office and we can send it over. Shannon stated the park needs new signage and Carl agreed. He stated the one in front on Martin Luther King is fading and the one by the statue could use a solar light which would also help along with the other upgrades we're making to the park.

Shannon recalled that Kellie McClellan asked for funds to cut down diseased trees and she wondered if the funds could be used for this. Carl stated he believed that could fall under beautification.

Carl mentioned he met today with Community Development regarding the renovation of Cabin 6 which will be getting started next week. They are looking at a timeline of 4-6 weeks to have it renovated which is a plus for McCulloch Park. We've also received inquiries about the return of Soap Box Derby to Muncie. All of these improvements will make the park very inviting to the citizens.

Chandra asked if there has been any talk about the restroom by the little playground at Heekin Park. Carl stated it is due to come down this summer. Community Development is aware of it and the Parks Department has removed everything out of it. It is an eyesore and though we don't have a timeline we have spoken with Steve Selvey, Building Commissioner about putting it on the list for removal.

Shannon wondered if some of the funds could be used to expand Disc Golf. Carl said he would hope we could as there has been a lot of interest. He received a call a few weeks back from the organization stating they were going to speak to Dustin to see if the baskets at Prairie Creek were being used and if not move them to increase the course at McCulloch Park.

Brad stated the Board will need a copy of the trust to review and understand what funds are available and asked if Carl will be coordinating efforts or if it will fall under George. Carl stated once we get the Board's approval, we will work together to ensure things are handled the right way, funds are moved the right way and report to the Board on those projects as they move forward.

Brad stated he believed they should send over a wish list to Carl and have legal review to make sure we are in compliance with the trust.

Shannon asked when Carl would like to receive the wish list items sent to him and he replied once the Board gives its blessing to move forward. There is no set timeline as

long as legal approves. We would also set up a meeting with the Whitely Neighborhood Association to get blessings from them as well.

Shannon stated she would go back through notes from last year to find the information for the gentleman that talked about Disc Golf. A gentleman raised his hand and Brad asked was that you guys and he stated it was.

Brad addressed the room and stated there were no details in old business and he will have something to discuss under new business. Shannon reminded him that he skipped over the Skate Park. Brad apologized to Ro Selvey and introduced her to the floor.

11. MUNCIE SKATEPARK FUNDRAISER – Ro Selvey, City Council at Large

The Skate Park team is working under Carl Malone and Robert Ivy. They have broken into two groups for this project. One will handle fundraising and the other will handle logistics.

She has met with John Anderson of Muncie Sports Complex and have discussed possible future skateboarding competitions. He stated that the project must show community interest and involvement before we fundraise.

She also met with Adam Unger, President and Founder of Accutech. They have created a software called PlyCrowd to accept donations and gifts. They will be using it for the first time for the Skate Park Project. They will waive all set up fees for the campaign and will help with the PR campaign. They will waive up to 5K and will assist with marketing services to amplify up to 10K and will waive fees for the fund collection and distribution if the goal is raised. They have set up the bank account to collect the donations and will release the funds to the Park Department to use at the appropriate time.

Ro stated they are looking for the \$5, \$10 and \$25 donors not just the major donors to show the community involvement. They are also working on in-kind donations from construction companies. They will come back at a later time to discuss donations and commitments.

The Skate Park will happen hopefully this year.

12. OLD BUSINESS

- There was no old business on the table.

13. NEW BUSINESS

Brad stated the bids for the rental space about the Prairie Creek office were delivered to Board of Works and they will ask us to review them. He is unsure how many there are,

but they are scheduled to open them tomorrow. If more than one the Board will need to meet to review the proposals. If there is only one we will accept it if it meets all the terms.

Legal counsel stated they could take a vote now to accept if there is only one bid. Brad said he would accept any motion to accept if there is only one bid received and if there is more than one, they will meet to review.

Vote was taken by all Board members present. Motion carries. Motion approved by all members present.

Shannon inquired how many rental offices there are and Brad stated there are three spaces up there, a kitchen, store and a restaurant. There could be bids in entirety, individual or a mix of spaces. Currently a renter has two of the spaces and one is empty. This renter was in place before we took over the building.

Brad inquired if there was any other business from the Board. There was none.

Brad inquired if there were any other events that needed to be approved. There were none.

16. PUBLIC INPUT – Please limit time to 3 minutes.

Brad reminded everyone this is public input not necessarily a discussion. We may have answers but that is not required. He opened the floor to the public if we had anyone that would like to speak.

Tommy Miller – Disc Golf

Mr. Miller stated this was good timing with the disc golf talk earlier in the meeting. He is with the Muncie Area Disc Golf Club which is a not for profit running three courses in Muncie, Yorktown and Dunkirk. They started with their first course in Muncie and in 2011 put in the one in Yorktown. They currently have approximately 50 paid members ranging from 9 – 68 years old. They have weekly tournaments. The Muncie course is one of the most used courses in the nation with 345 rounds scored on the UDisc App approximately 1500 people. This year they have done fundraising to buy new baskets approximately \$8,000, installed new signs in Muncie and Yorktown, cleared out the course of Honeysuckle, donated to charities like ARF and representing Muncie in the Indiana Club Challenge this year. They would like to expand the course at McCulloch Park by adding 6 more holes. They would like to pull the 17 baskets from Prairie Creek as they aren't used and store them at McCulloch until they course is expanded. They would also like if they could get a new welcome sign and a bridge built by the waste water treatment building over the little creek.

Shannon requested quotes on what these requests would cost at the next meeting. Tommy stated they will do all the removal of the baskets at Prairie Creek so there won't be a cost. They just need to know when they can do it so they are doing it correctly.

Brad inquired what the vision is. Is it to add a new course at McCulloch or build elsewhere and Tommy stated he would like to expand McCulloch to 24 holes. There is room to expand by the softball diamond and the behind the cabin. It would take us from a B+ course to an A- which would bring even more people to the course.

Shannon inquired about parking and bathrooms. Tommy responded they usually park by the fire station but when they have a tournament they park there and by the derby hill. They typically rent a port-a-pot for tournaments as there aren't many bathrooms available in the park.

Brad inquired if there was something that could make the Prairie Creek usable or if they tried and abandoned the idea. Tommy said it is primarily location as it is probably hard for the staff to get back there and mow. They have removed several stumps and grinded but it may be more of a hassle than it's worth and is also in the way of everyone hanging out by the docks.

Shannon asked for him to come to the next meeting and bring some figures so we can possibly find funding in the current budget. Chandra stated there might be a possible grant for the sign and she will look into it. Tommy said he will put together some quotes and bring them next month.

Brad asked if there were any other public comments.

Carl wanted to go on record about the Deputy Mayor and soccer, the Mayor for his vision and the Board for coming in and doing a great job and being hands on in such a short time. He thinks the city is in good hands and the parks are going in the right direction.

Meeting was adjourned by Brad Marshall, President.
