ORDINANCE NO. 3-24

APPROPRIATION ORDINANCE
CITY OF MUNCIE, INDIANA

WHEREAS, the Common Council of the City of Muncie, Indiana (the "Council" and the "City", respectively) has determined to proceed with the construction of a new fire station to replace the existing Fire Station #6 in the City, together with all necessary appurtenances, related improvements and equipment (the "Project"); and

WHEREAS, the Council has determined that the estimated cost of the Project, and the incidental expenses necessary to be incurred in connection with the Project, including reimbursement to the City, and with the issuance of bonds and, if necessary, bond anticipation notes (the "BANs"), to finance the Project, will be in an amount not to exceed Eight Million Seven Hundred Thousand Dollars (\$8,700,000); and

WHEREAS, the Council has determined to issue local income tax revenue bonds and, if necessary, BANs, in an aggregate principal amount not to exceed Eight Million Seven Hundred Thousand Dollars (\$8,700,000) to fund the costs of the Project; and

WHEREAS, there has been published a notice of a public hearing on the appropriation of the proceeds of the local income tax revenue bonds and, if necessary, BANs, to be held on this date, the hearing has been held and the Council has considered the evidence presented at the hearing; and

WHEREAS, the Council now finds that the City does not have sufficient funds available or provided for in the existing budget and tax levy to fund the cost of the Project;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA, THAT:

Section 1. The Council finds that all proceedings required before appropriation of the proceeds of the local income tax revenue bonds and, if necessary, BANs, have been accomplished and completed.

Section 2. For the purpose of paying a portion of the cost of the Project, including reimbursement to the City, and incidental expenses necessary to be incurred with the Project and the local income tax revenue bonds and, if necessary, BANs, an amount not to exceed Eight Million Seven Hundred Thousand Dollars (\$8,700,000) shall be appropriated from the proceeds of the local income tax revenue bonds and, if necessary, BANs.

Section 3. The Controller is directed to submit and certify this ordinance and the related proceedings to the Department of Local Government Finance in accordance with Indiana Code 6-1.1-18-5.


Section 4. This ordinance shall be in full force and effect from and after its passage and execution by the Mayor.

NOTICE TO TAXPAYERS OF PUBLIC HEARING ON ADDITIONAL APPROPRIATION

Notice is hereby given to taxpayers of the City of Muncie, Indiana (the "City"), that the Common Council of the City will meet in the Muncie City Hall Auditorium, 300 North High Street, Muncie, Indiana, at 6:45 p.m. (EST) on April 1, 2024 to conduct a public hearing and consider an appropriation of the funds of the City in an amount not to exceed \$8,700,000 from proceeds of local income tax revenue bonds and, if necessary, bond anticipation notes of the City to be applied on the costs of the construction of a new fire station to replace the existing Fire Station #6 in the City, together with all related improvements, equipment and incidental expenses in connection therewith.

The foregoing appropriation is in addition to all appropriations provided for in the existing budgets and levies.

Taxpayers of the City appearing at the hearing shall have a right to be heard in respect of this additional appropriation.
