ORDINANCE NO. 39-24

**AN ORDINANCE REPEALING CHAPTER 55 OF THE MUNCIE CITY ORDINANCES  
ENTITLED CABLE TELEVISION**

**WHEREAS**, Chapter 55 purports to regulate the activities of grantees of local television franchisees; and

**WHEREAS**, the Muncie Common Council passed Ordinance 25-04, which removed the authority of the Muncie Cable Television Commission to regulate subscriber rates, effective October 4, 2004; and

**WHEREAS**, the City of Muncie is no longer allowed to enter into franchise agreements with cable television providers after June 30, 2006, as that function has passed to the state level from the local level;

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:**

**Section 1.** That Chapter 55 is repealed in its entirety.

**Section 2.** This Ordinance shall be in full force and effect upon its passage by the Common Council, its approval by the Mayor of the City of Muncie and its publication in accordance with the law.
