

#### **CR-05 - Goals and Outcomes**

#### Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

The U.S. Department of Housing and Urban Development (HUD) awards various funding resources to Entitlement Communities across the United States. HUD bases awards on formula calculations, including factors such as the community's population, pre-1940 housing stock, growth, and decline. The City of Muncie, located in Delaware County, east-central Indiana, received \$1,276,642 for the Community Development Block Grant (CDBG) and \$510,434 (15% less than the previous year) in HOME Investment Partnerships Program (HOME) funds for the 2024 Program Year (PY) running from June 1, 2024, to May 31, 2025.

The Consolidated Annual Performance and Evaluation Report (CAPER), or year-end report, discusses the accomplishments from PY 2024. Muncie focused resources on homeowner repair, public services, public facilities (park improvements and street paving) and demolition.

During PY 2024 the City was awarded \$1,099,212 in Cares Act (CDBG-CV) funds. In PY 2024 the city continued to spend down (CDBG-CV) funding. The final project, Crisis Center was cancelled vial amendment and those funds have been allocated for new bathrooms at Thomas Park.

These efforts aligned closely with annual Action Plan priorities, though rising construction costs, limited contractor availability, and earlier COVID-19 disruptions reduced the scale of some accomplishments. Despite these challenges, the City consistently directed resources toward high-priority needs, maintained compliance with financial requirements, and demonstrated progress in housing, services, neighborhood stabilization, and infrastructure to benefit low- and moderate-income residents.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

CDBG resources were strategically applied to public facility and infrastructure improvements in low- and moderate-income neighborhoods, including street, sidewalk, and park upgrades, which directly support the objective of improving neighborhood livability and safety. Public service funds were directed to nonprofit partners serving homeless residents. CDBG also funded demolition of unsafe structures, eliminating slums and blight and supporting neighborhood stabilization.

The CDBG activities awarded in PY 2024 that moved forward include:

- 1. The City of Muncie incurred administration costs totaling \$251,637.
- 2. Muncie allocated \$200,000 for homeowner repair services, which funded 8 roofs. Working in conjunction with subrecipient HomeSavers 2

furnaces, 5 tub to shower conversions and one water line replacement were completed. While all activities are still open, 16 households were assisted in PY 2024.

- 3. The City used \$134,597 to demolish 17 blighted structures in PY 2024.
- 4. The bathhouse roof was replaced at Tuhey Park (\$112,807.91.)
- 5. YWCA of Central Indiana used \$53,568 to assist 606 women and children in Muncie.
- 6. Muncie Mission Ministries used \$67,456 to assist 1,181 Muncie residents.
- 7. Christian Ministries used \$17,856 to provide cold-weather shelter for 66 Muncie residents.
- 8. A Better Way used \$40,672 to provide wrap-around services to 106 Muncie residents.
- 9. Recovery Café used \$11,904 to assist 469 Muncie Residents.

The City completed activities from past years as follows: PY 2020 Environmental Studies

PY 2022 McCulloch Park Lodge Rehabilitation

PY2023 Habitat, EcoRehab and Homesavers Homeowner Rehab;

Paving projects on E 9th, S. High and S. Vine Streets

Because of the COVID-19 pandemic, HUD awarded a special allocation (1,099,212) of CDBG-CARES Act funding called CDBG-CV. The Continuum of Care grant was expended and closed and all remaining funds were reallocated to the Thomas Park Restroom project. \$8,500 of CDBG CV funds were expended in PY 2024 for Thomas Park Restrooms. \$61,603.02 remained in the CDBG CV Grant at the close of PY 2024.

The City spent no 2024 HOME Funds, however the following projects were completed with funds from previous years: six first time homebuyers received down payment/closing cost assistance and two phases of City View LIHTC Apartments were completed, with four HOME assisted units in each phase. During the 2024 program year funds were expended but the activities remain open: Homebuyer development projects at 1720 S. Jefferson (EcoRehab); 125 E. 9th and 1403 W 10th (Habitat); 612 W 5th Pathstone. Southern Terrace LIHTC apartments were funded for four home assisted units. The project is near completion.

Muncie's deployment of funds demonstrates a strong connection between planned priorities and actual accomplishments. The focus on affordable housing, basic infrastructure, elimination of blight, and support for vulnerable populations reflects adherence to the highest priority needs, while ensuring compliance with national objectives and HUD requirements.

#### **Narrative**

During the reporting period, the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) programs collectively assisted a total of 2,312 individuals through CDBG and 60 individuals through HOME-funded activities.

#### Racial Breakdown:

The majority of beneficiaries identified as White, comprising 1,713 individuals under CDBG and 33 under HOME. Black or African American families represented the second largest racial group, with 577 assisted under CDBG and 27 under HOME. Smaller numbers of beneficiaries identified as Asian (9 CDBG, 0 HOME), American Indian or Alaska Native (10 CDBG, 0 HOME), and Native Hawaiian or Other Pacific Islander (3 CDBG, 0 HOME).

#### Ethnic Breakdown:

Of the total individuals assisted, 18 CDBG and 2 HOME beneficiaries identified as Hispanic. The remaining 2,294 CDBG and 58 HOME beneficiaries identified as Non-Hispanic.

#### **Narrative**

Muncie used CDBG, CDBG-CV, HOME and HOME ARP funds for activities that met priorities from the Consolidated Plan and the PY 2024 Action Plan. The City utilized funds targeted to meet the greatest needs, and expenditures were directly related to programs that supported the City's Consolidated Plan.

The City of Muncie expended \$1,157,706.54 of CDBG entitlement, \$8,500 of CDBG-CV, and \$1,329,440.40 of HOME funding.

#### **Narrative**

Muncie does not identify specific target areas; funds are used citywide. Approximately 51% of Muncie's neighborhoods are occupied by households earning less than 80% of the Area Median Income (AMI). As a result, the City is considered a low- to moderate-income area.

Muncie provided programs and services identified in its Consolidated Plan to assist income qualified or presumed-eligible households and individuals. Most activities served eligible low-income households on a citywide basis.

#### **Narrative Information**

In the past Muncie has contracted with subrecipeints to work with homeowners on roof replacement projects. We have changed to a different model, contracting for the estimating, quoting and project supervision of roof replacement projects. This has allowed us to complete more projects in less time. Our homebuyer development partners are experiencing increased construction costs and problems finding contractors slowing down progress on these projects. The CDBG Households reflected above participated in the Housing Rehab Program. The HOME households reflected above participated in rental (8 units) and homebuyer development with DPA/CCA (1 unit) assitance or DPA CCA assistance only (5 units)

## Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Homeless outreach in Muncie involves connecting unsheltered individuals and families with shelter, basic needs, and supportive services. Outreach teams engage people where they are—on the streets, in encampments, or in public spaces—to build trust and offer assistance with housing, health care, and other resources. The goal is to reduce barriers, link individuals to coordinated entry, and support their transition to stable housing. Muncie has limited all Public Service funds to agencies that serve the homeless directly or provide programs that address causes of homelessness.

#### Addressing the emergency shelter and transitional housing needs of homeless persons

Muncie continues to address the emergency shelter and transitional housing needs of individuals and families experiencing homelessness through a network of local providers that offer year-round shelter, food, and support services. These facilities serve diverse populations, including individuals, families with children, and survivors of domestic violence. Transitional housing programs help bridge the gap between shelter and stable housing by providing time-limited housing and supportive services focused on stability and self-sufficiency.

To further strengthen the housing continuum, a new 38-unit permanent supportive housing project has been funded and is currently in the planning stages. This development will provide long-term, service-enriched housing for individuals with high needs, such as those experiencing chronic homelessness or living with disabilities. Once completed, it will significantly expand local capacity to provide stable, affordable housing with on-site support, helping residents maintain housing and improve overall well-being. The project will utilize both HOME and HOME ARP funding.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

To help homeless individuals and families transition to permanent housing and independent living, the City of Muncie employs a coordinated system that prioritizes those with the greatest needs—especially chronically homeless individuals, families with children, veterans, and unaccompanied youth. Through

the Coordinated Entry system, individuals are connected to shelter, housing options, and supportive services that aim to reduce the time they remain homeless and increase access to stable, affordable housing.

A key resource is the Rapid Rehousing program, which provides short-term rental assistance, help with utility payments, and damage deposits to remove financial barriers to housing. This program helps households quickly move into housing and regain stability. Once housed, individuals may receive ongoing support to maintain housing, including assistance with health care, employment, and other services. While follow-up care is available for those discharged from mental health institutions, there is currently a gap in services for individuals exiting jails or correctional facilities. The planned 38-unit permanent supportive housing project will further expand options for long-term, service-enriched housing for individuals with higher needs.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Muncie supports homeless individuals and families—especially those who are chronically homeless, families with children, veterans, and unaccompanied youth—by connecting them to emergency shelter, housing navigation, and supportive services through a coordinated entry system. These efforts prioritize those with the greatest needs and aim to reduce the time spent without housing, facilitate quicker access to affordable units, and ensure long-term housing stability.

Follow-up care and housing coordination are available for individuals discharged from mental health institutions, helping them transition into stable environments with supportive services. However, there are currently no dedicated resources for individuals exiting jails or correctional facilities, which presents a gap in preventing reentry into homelessness. A new 38-unit permanent supportive housing development in planning will help meet the ongoing needs of those requiring long-term, service-enriched housing, further supporting the transition to independence and reducing recidivism into homelessness.

CD director meets regulary with the CEO and COO of Muncie Housing Authority. In addition, MHA's CEO is now attending weekly meetings of homeless services providers and MHA staff also attends Continuum of Care meetings. MHA has instituted preferences for homeless individuals and families.

## Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

MHA leads activities to increase resident involvement in public housing include establishing or supporting resident councils, hosting community events such as job fairs and health fairs, and encouraging participation in planning and improvement discussions. Educational workshops and referrals to local housing counseling agencies are available to promote financial literacy and inform residents about pathways to homeownership.

#### Actions taken to provide assistance to troubled PHAs

Muncie Housing Authority is not "troubled."

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

The Analysis of Impediments to Fair Housing found there are no public policies that serve as barriers to affordable housing.

#### Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

The allocation priorities outlined in Muncie's plan are based on clearly identified needs, including aging housing, cost burdens for low-income households, deteriorated infrastructure, and limited services for vulnerable residents. Resources are targeted toward preserving and developing affordable housing, assisting people experiencing or at risk of homelessness, and upgrading public facilities in neighborhoods with the greatest need. These priorities aim to improve living conditions and ensure all residents have access to safe, stable housing and essential services.

#### Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

City of Muncie Community Development Office, ensures that subrecipients, CHDOs, contractors, and subcontractors use lead-safe work practices by including lead-safe work practices in the written agreements made with subrecipients, CHDOs, contractors, and subcontractors. Both tenants and homebuyers of rehabilitated buildings receive information on Lead-Based Paint and how to protect themselves and their families from Lead-Based Paint hazards. Community Development requires that a Lead-Based Paint inspection be carried out by a certified inspector on all buildings built before 1978, receiving CDBG and HOME funds for rehabilitation, except where the action is exempt.

In compliance with the requirements of 24 CFR Part 35, Lead Hazard Reduction Program, the MCD notifies owners and tenants of CDBG- and HOME-assisted target housing constructed prior to 1978 about the hazards, symptoms, and treatment of lead-based paint, and the precautions to be taken to avoid lead-based paint poisoning. The notice includes the HUD pamphlet, Protect Your Family from Lead in Your Home.

Homes built before 1978 are assumed to have lead-based paint; therefore, a work area is tested before any home rehab is done by a certified lead-based paint inspector or lead-based paint risk assessor. Assessment can be done by collecting paint chips for laboratory analysis or by testing painted surfaces with an XRF (X-Ray Fluorescence Analyzer) machine, which measures the amount of lead in paint. A report documenting the testing lists the surfaces tested and the surfaces which contain lead-based paint. If lead-based paint is present on an affected surface, then the lead-safe work practices are implemented to remove the lead-based paint, which includes required notification within 15 days after

lead-based paint, or lead-based paint hazard are identified in the home, the unit (or common areas, if applicable), and within 15 days after completion of hazard control work in the unit or common area. Muncie Community Development follows the CPD Flow Chart - HUD Lead Safety Rules (based on CFR Part 35, subpart A (Disclosure), and subparts B-R (Lead Safe Housing Rule).

#### Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

The Together DM Comprehensive Plan for the Delaware-Muncie Region approved in January of 2022 established a priority to expand opportunities for upward mobility. The plan identifies these opportunities downtown, in neighborhoods and in parks and connective corridors and partnerships to boost education and upward mobility.

Downtown is a highly accessible location with a range of entry-level to advanced employment opportunities. Maintaining and growing this level of diversity and accessibility is important. And so is ensuring that affordable residential opportunities continue to exist as downtown becomes a true neighborhood.

Main Streets have historically served as incubators for small businesses and as sources of part-time employment to supplement family incomes. Having high quality commercial space and supportive services for small business development—including connections to the local agricultural economy—has the potential to nurture small, locally-owned businesses that are uniquely tied to their communities.

Highly concentrated poverty at the neighborhood level has been found to be one of the most important limiting factors on upward economic mobility for low-income families. Disrupting these concentrations and providing more people with access to healthy neighborhood environments is critical, as is the use of educational institutions and partnerships to prepare children for success

The condition of parks and major streets influences how confident homeowners are about their neighborhoods and the degree to which reinvesting in their house makes sense. It also influences how interested prospective buyers are when they compare their options in Delaware County or the wider region.

While place-based initiatives can play a role in expanding economic opportunity and reducing concentrated poverty, improving levels of educational attainment will require long-term efforts by a web of partners working community-wide. Cradle to Career Muncie represents the type of collective impact effort that will be needed to make and sustain the upward mobility goals, and is the type of partnership needed to advance much of Together DM's vision.

#### Actions taken to develop institutional structure. 91.220(k); 91.320(j)

To strengthen its institutional structure, the City of Muncie has focused on enhancing coordination among public agencies, nonprofit organizations, and community stakeholders involved in housing,

homelessness, and community development efforts. This includes continued support for the local Continuum of Care and expanding partnerships with organizations that provide health, employment, and social services to better align resources and avoid duplication.

The City supports building capacity of local subrecipients and CHDOs by offering technical assistance, streamlining administrative processes, and promoting collaborative planning. By improving communication, leveraging shared data, and encouraging cross-sector partnerships, Muncie aims to create a more responsive and efficient service delivery system capable of meeting the community's evolving needs.

## Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

To enhance coordination between public and private housing and social service agencies, the City of Muncie convenes regular meetings with key stakeholders, including housing providers, nonprofit organizations, health agencies, and service providers. These efforts support shared planning, improve referral systems, and ensure that services are aligned with the needs of low-income and vulnerable residents.

The City also works closely with the Continuum of Care and Community Housing Development Organizations (CHDOs) to coordinate housing development with supportive services. By fostering stronger relationships between public and private partners, the City aims to create a more integrated service delivery system that promotes housing stability, economic mobility, and improved quality of life for Muncie residents.

Activities and subrecipients are assessed using a risk analysis that considers factors such as funding amount, past performance, staff capacity, and compliance history. High-risk activities receive more frequent and intensive monitoring.

A formal monitoring schedule is developed annually. Subrecipients are notified in advance and provided with a monitoring checklist outlining required documentation and areas of review.

#### Desk and On-Site Reviews

Monitoring includes both desk reviews of quarterly reports, reimbursement requests, and supporting documentation, as well as on-site visits to review financial records, client files, and program delivery.

#### Compliance with Federal Requirements

Monitoring ensures compliance with program-specific regulations, including income eligibility, property standards, environmental review, and procurement rules. Findings and concerns are documented, and corrective actions are required as needed.

#### Long-Term Compliance

For activities such as housing development or rehabilitation, long-term compliance is ensured through recorded legal agreements, regular property inspections, and annual reporting on continued eligibility and affordability requirements.

#### Minority and Women-Owned Business Outreach

The City promotes the participation of minority-owned and women-owned businesses in all federally funded projects. Outreach includes publishing bid opportunities, maintaining a directory of MBE/WBE firms, and requiring subrecipients and contractors to report on MBE/WBE participation.

#### **Comprehensive Planning Coordination**

Activities are monitored for alignment with the goals and priorities outlined in the Consolidated Plan. Coordination with other planning efforts—such as transportation, economic development, and public infrastructure—ensures a holistic approach to community development.

#### **Documentation and Reporting**

All monitoring activities are documented, and summary reports are maintained. Issues identified through monitoring are followed up with technical assistance, corrective action plans, and, if necessary,

enforcement measures.

These procedures help ensure that resources are used effectively, regulatory requirements are met, and program goals are achieved with transparency and accountability.
